**SIGNIFICANT NATURAL RESOURCE AREAS MANAGEMENT PLAN - Certification of the Final Environmental Impact Report** - The proposed project is the Natural Resource Management Plan (formerly named Significant Natural Resources Area Management Plan or SNRAMP). The Natural Resource Management Plan (NRMP) contains detailed information on the

biology, geology, and trails within 32 Natural Areas, 31 of which are in San Francisco and one (Sharp Park) is in Pacifica. The NRMP is intended to guide natural resource protection, habitat restoration, trail and access improvements, other capital projects, and maintenance activities over the next 20 years.

**NOTE: The public hearing on the Draft EIR is closed. The public comment period for the Draft EIR ended on June 11, 2012. Public comment will be received when the item is called during the hearing. However, comments submitted may not be included in the Final EIR.**
