

Hello I want to give you another reason why project 2016-010079COA, Block 459 Lot 3 known as 3620, 3636, 3640 Buchanan and 1595 Northpoint, should not be permitted to demolish the park area and the garden shop building located in the southern portion of the lot. Recall, I previously provided you copies of historic city official documents about Resolution 88 and Block 459 Lot 3.

The project developer hired Page and Turnbull consultants to prepare a report showing that no historical significance was identified for the property. The project developer sent a copy of that document to the Planning Dept.

The Page and Turnbull document completely ignores the 1974 Resolution 88 passed by the Landmark Preservation Advisory Board (LPAB) which explicitly defined the entire area of Block 459 Lot 3 as historic landmark 58.

Prior to 1974, the then owners of Block 459 Lot 3 restored the

manufactured gas plant office building and from Resolution 88 "added an equally impressive garden shop and handsomely landscaped spacious areas", that shop and landscaped areas being proposed for demolition.

The 1974 landmark Resolution 88 recognized the shop and landscaped area as an historic artistic entity. The **LPAB explicitly** defined the entire area of Block 459 Lot 3 as the historic landmark, including the office building, landscaped areas and the garden shop building.

Because the Page and Turnbull document ignores Resolution 88, it is

invalid and needs re-working.

Dear Sirs and Madams:

With the June 13 re-hearing date fast approaching on the "Early Days" statue, I can't thank each and every one of you enough for rendering the past decision that could only be rendered-that the Arts and Historic Preservation Commissions erred when deciding (to their everlasting shame), that it was within their authority to remove this artwork. Such decisions are in essence, irrevocable, unless the law is changed and cannot simply be overturned based on the whim of even a substantial number of people, who are sorely misrepresenting the intentions of Frank Happersberger who was a prominent artist in his day and won the commission to create it.

I listened to many speakers who testified in favor of removal; it quickly became quite clear they were speaking of the greater ills of how the Indians were treated throughout history: "genocide", "racism", "stolen lands taken from our ancestors", were repeated themes. Mariposa Villaluna, who reportedly spearheaded removal efforts, and spoke in fevered pitch, was clearly waging a personal war while disrespectfully allowing her child to whine the whole time, disrupting the meeting. So an innocent statue made for ALL San Franciscans is now being viciously scapegoated for past actions that spanned centuries? No matter their thoughts, they have no right to "steal" a piece of art from those like myself who relish its beauty and representation of a monumental period of California history. No one, save Andrew Galvan, who is the Old Mission Curator at Mission San Francisco de As is (next to Mission Dolores Basilica) knew or cared anything about mission history. Mr. Galvan, I understand, attended the canonization ceremony in Rome of Saint Juniper o Serra. Of actual abuses within the mission system, many of the soldiers were to blame. Does it make sense that the Franciscan Friars would embrace the native peoples within the moral arena, by teaching them to read music and create art, if they only had malevolent or uncaring feelings toward them? Can the literally tens of thousands of Indians who built the 21 missions be wrong, missions that were so endearing that Hollywood, Alfred Hitchcock, used one in his famous movie, "Vertigo"? However one feels about the statue, it still does not negate the fact that the Native Peoples built the missions, with help from the friars, and the statue honors that tremendous effort.

And it is outrageous that SF Chronicle columnist Caille Millner (June 9, "Another chance to get rid of demeaning relic")likens the statue to the Confederate symbols removed in the South. Granted, the Confederate leaders truly did have racist thoughts and actions, but what is the point when they were buoyed by the millions who wanted institutionalized slavery to prevail? This was an ugly sign of the times in which a few leaders are targeted when a majority of the populace was to blame. The ridiculous actions of removing statues and renaming streets and freeways speaks more to the token actions of those indulging in feel-good attempts at self-gratification, while sadly taking away from meaningful change such as

working in schools with mandatory courses teaching children that all are the same, no matter if skin color is different. And legislation must be strengthened and expanded to clamp down wherever discrimination erupts. And of course, there can be no more important place than in the homeit is incumbent upon all parents to teach their children that no one is better because they are smarter, or more popular, or have a different skin color.

So the impetus of the trend toward removal has propelled many to try the same with "Early Days". I wonder if those in opposition would care to know that the irony is that, at least for myself, the statue has made me more than ever appreciative of the endurance of the Native Americans, and has fueled my interest in them. Recently, while in Yosemite, I visited the Indian Museum and spoke with a Maidu tribal member to discover the names of the tribes that built the missions-(Chumash, in large part). I find it fascinating the detail given to, for example, the perfectly diagonal multi-colored artwork on the ceiling of the Old Mission. On my own, I have learned of two patron saints of Native Americans, St. Kateri Tekakwitha (born in 1656 in the Iroquois Confederacy- modern-day New York), who is referred to as the "Lily of the Mohawks" and known for her actions protecting the environment, and also, St. Juan Diego, born in 1471 in Mexico and who is the first indigenous saint of the Americas.

You are all reasonable and honorable people lease ensure that the "Early Days" component of the magnificent Pioneer Monument, remains in perpetuity.
