2nd ANNUAL WEST COAST MAYORS SUMMIT ADDRESSES INFRASTRUCTURE AND RESILIENCY

Mayors discuss importance of upgrading and improving infrastructure in preparing for the next big West Coast disaster

San Francisco, CA— Mayors gathered to discuss their shared commitment to upgrade and protect our cities' aging infrastructure and improve resiliency for our communities against the threat of natural and human-made disasters. This is the second day of discussions at the 2nd annual West Coast Mayors Summit hosted in San Francisco. Housing and Urban Development (HUD) Secretary Julian Castro joined the conference on Tuesday to discuss housing, homelessness, resiliency, and how to further cities' agenda in pursuing federal assistance.

On Tuesday, mayors met at the Exploratorium at Pier 15 to share their experiences dealing with deteriorating infrastructure and how to leverage local and federal funds to invest in improving underground pipelines, roads, seawalls, buildings and public facilities such as ports, airports, hospitals, etc. Mayors also discussed specific examples of projects that need immediate attention and how to work together to pursue federal funding for such projects.

"Disasters are a fact of life," said San Francisco Mayor Ed Lee. "As leaders of the West Coast we have an obligation to make our cities stronger and more resilient for our children and future generations and by working together we can achieve more for our residents."

All West Coast cities convening in San Francisco are located in active seismic zones, share the same threat of earthquakes, tsunamis, and fires and need to invest heavily in upgrading their infrastructure to withstand the next big one. Apart from saving human lives and minimizing suffering, investing in pre-disaster mitigation makes economic sense. Studies have proven that every dollar spent on strengthening critical infrastructure will save the federal government at least five dollars in post disaster recovery. Historically proven, infrastructure projects improve communities, create jobs, and strengthen economies.

"All major cities need to prepare for the 'new normal' resulting from emerging long-term challenges, like drought and climate change," said San Jose Mayor Sam Liccardo. "That is why we are focused on advancing critical infrastructure projects that promote sustainability and protect our residents from natural disasters."

"It's not a question of if, but when, a major Cascadia Subduction Zone seismic event will strike our Northwest region," Portland Mayor Charlie Hales said. "Retrofitting our outdated, aging infrastructure is a fundamental public safety priority that will protect thousands of Portlanders lives."

The West Coast cities are considered economic hubs in their states which contribute over \$3.2 trillion to the US economy (18% of the national GDP). A major disaster on the West Coast could disrupt the region and major sectors in other parts of the country. The cost of inaction is too expensive for the entire country to bear. Mayors agreed to a specific set of measures and recommendations that promote resiliency as an essential criteria to qualify for federal funding. Such criteria could be applied to any city in the USA and result in better utilization of federal funds.

"Seattle is a leader in developing and implementing cutting edge climate solutions that specifically address the disproportionate impact of climate change on communities of color," said Seattle Mayor Ed Murray. "Looking forward, we will work with our new resiliency officer to ensure Seattle is prepared for the environmental challenges we continue to face, and that we keep cutting our emissions even as we grow."

"An investment in infrastructure is an investment in people, and our collective goal is to ensure our cities are prepared for the threat of hurricanes, tsunamis, earthquakes, and other natural disasters," said Honolulu Mayor Kirk Caldwell. "In Honolulu, there's an urgent need to prevent a 100 year flood of the Ala Wai Canal that would devastate surrounding communities like Waikiki. Our local businesses and residents need federal support to fund critical city and state projects that would help Honolulu survive a major disaster."

Mayors signed a joint letter to President Elect Trump requesting allocation of \$200 billion of his proposed infrastructure plan to West Coast cities. Such an investment will help cities improve their aging infrastructure, create jobs, improve economic stability, and more important reduce human loss of lives and suffering caused by natural disasters. Mayors also requested ongoing funding for the West Coast earthquake early warning system used in other countries such as Japan, Mexico, India, Italy, etc.

MAYOR LEE ANNOUNCES RELEASE OF CITY'S FIVE-YEAR FINANCIAL PLAN

Focus on long-range planning ensures San Francisco remains a resilient City prepared for the future

San Francisco, CA—Mayor Edwin M. Lee introduced at the Board of Supervisors the City's Five-Year Financial Plan (Financial Plan) for Fiscal Years (FY) 2017-18 through 2021-22. Over the next five years, the Financial Plan projects that the City will experience continued economic growth; however, the plan also notes that revenue growth is slowing.

The Financial Plan shows that the cost of City services is projected to outpace revenue growth during the five-year period. If the City does not take corrective action, the gap between revenues and expenditures will increase to approximately \$848 million by FY 2021-22.

"During the last six years, I am proud that the City's strong economic growth has allowed us to expand and improve city services – for instance, expanding MUNI services by 10%, increasing public protection staffing in line with our Public Safety

Hiring Plan and improving the availability and quality of health and human services for the City's most needy. However, many uncertainties lie ahead," said Mayor Lee. "Financial stability is central to the City's ability to provide sustainable services to the public. Staying disciplined today will ensure we are more resilient as a City over the long term."

"This report highlights the need for continued financial discipline inside of City Hall," said Supervisor Farrell. "As a City we are going to have to make difficult choices, but along with the Mayor I am committed to making sure our City is on solid financial footing for the next generation of San Francisco residents."

The City's budget deficit for the upcoming two fiscal years, FY 2017-18 and FY 2018-19, is projected to reach approximately \$400 million. The Mayor submitted a budget rebalancing plan last week to address changes in revenues and expenditures following the November 2014 election. This plan balances the need for increased spending on homelessness, street trees, City College and increased legal services for immigrants.

The Five-Year Financial Plan is required under Proposition A, a Charter amendment approved by voters in November 2009. The City Charter requires the Financial Plan to forecast expenditures and revenues during the five year period, propose actions to balance revenues and expenditures during each year of the Plan, and discuss strategic goals and corresponding resources for City departments. The Five-Year Financial Plan is part of a comprehensive effort by the City to improve its long-range financial management and planning.

The City currently projects revenue growth of \$560 million, or 11% over the five year period of this Financial Plan. Overall, growth rates are projected to continue slowing through the report period and the pace of revenue growth during the projection period will depend heavily on the strength of the national economy, local technology industry, and federal policy.

However, the Financial Plan shows that the cost of City services are projected to outpace revenue growth during the five year period. Expenditures are expected to grow by \$1.4 billion, or 29% over the period. Over the next five years, employee salary, pension, and fringe benefit costs are growing by \$698 million (50 percent of total expenditure growth) and Citywide operating costs are growing by \$450 million (32 percent of total expenditure growth) and costs of voter-mandated baselines and set-asides are expected to grow by \$212 million (15 percent of total expenditure growth). If the City does not take corrective action, the gap between revenues and expenditures will rise from \$119 million to approximately \$848 million from FY 2017-18 to FY 2021-22.

As required, the City will need to implement strategies to close the gap between sources and uses and preserve fiscal stability. The Financial Plan proposes a package of balanced solutions to address the gap, including managing employee wage and benefits costs, capital and debt restructuring, identifying additional revenues, limiting non-personnel inflation, and implementing ongoing department solutions. The fiscal strategies, if implemented, will still allow the City's budget to grow by 16 percent over the next five years. The Financial Plan includes a detailed focus on the potential impact of an economic downturn on the City's five year outlook. The average length of time between recessions in the United States has been about four years, and the current economic expansion began over seven years ago. The City is closely monitoring changes in the economy as well was federal funding. This report does not assume significant changes in funding from the federal government; however, particular areas of concern include changes or repealing of the Affordable Care Act and increased need for service or reductions in funding related to the City's immigrant population and Sanctuary City status. The update to this report in March 2017 is likely to contain additional details on potential fiscal impacts at the federal level.

If an economic slowdown were to occur or the City experienced a loss of federal funding, the proposed fiscal strategies in this report would be insufficient to close broader gaps between revenues and expenditures. In such an event, the City would be required to take more significant measures to bring budgets back into balance.

The Chief Resilience Officer works under the supervision of City Administrator to oversee City policy and implementation on resilience, including the Capital Planning Program, Earthquake Safety Implementation Program and Lifelines Council.

As City Administrator I established the Lifelines Council to bring public officials together with academic experts, members of the public and private utilities and ensure a swift recovery for San Francisco after the next significant event," said Mayor Lee. "Brian Strong created the City's Capital Plan and brings more than a decade of proven leadership to this vital resilience work. I am pleased to announce his appointment as San Francisco's Chief Resilience Officer."

About Brian Strong

As the Director of the San Francisco's Capital Planning Program, Brian Strong is responsible for the City's \$32 billion 10-year Capital Plan and its \$450 million capital budget. Brian created the City's first multi-year capital plan in 2006 and has been instrumental in the development and passage of \$2 billion in General Obligation bonds specifically addressing earthquake safety and resiliency. Brian has also implemented a number of innovative resiliency programs to protect San Francisco's infrastructure, including the Earthquake Safety and Emergency Response bond program, the nation's first Sea Level Rise Guidelines, and the first building-by-building HAZUS assessments to evaluate facility performance, economic impacts, casualties, and other risks associated with earthquakes. Brian currently chairs the Sea Wall Finance Working Group to identify funding to seismically strengthen the Great Sea Wall that runs from Aquatic Park to the AT&T Park.

Under Brian's leadership, the Capital Planning Program received the 2011 Good Government Team Award from the Mayor's Fiscal Advisory Committee and the San Francisco Planning and Urban Research Association.
