### **Proposed Project**

- Retains existing façade
- 13-story mixed-use building with no setback
- Vertical hyphen (3-4 feet) at level 4
- 111 residential units
- 1,300 sf of retail or residential amenity uses



#### **Project Variant**

- Full demolition
- 13-story mixed-use building with no setback
- Vertical hyphen (3-4 feet) at level 4
- 116 residential units
- 1,300 sf of retail or residential amenity uses



# **SIGNIFICANT AND UNAVOIDABLE IMPACTS: PROJECT AND VARIANT**

Impact	Proposed Project	Project Variant
Substantial adverse change in the significance of a historical resource	YES	YES

## PRESERVATION ALTERNATIVES

#### **No Project**

- 2-story public parking garage (no change from existing)
- 119 public vehicle parking spaces



#### **Full Preservation**

- 6-story mixed-use building
- Retains front half of existing building
- Adaptive reuse of interior
- 30-foot setback to 2-story addition
- 2 additional stories at rear
- 36 residential units
- 1000 sf of retail or residential amenity space



#### **Partial Preservation**

- 13-story mixed-use building
- Retains existing façade
- 18-foot setback
- 111 residential units
- 1,840 sf of retail or residential amenity space
