# MAYOR MARK FARRELL, ASSEMBLYMEMBER PHIL TING, AND MEMBERS OF THE BOARD OF SUPERVISORS CELEBRATE \$10 MILLION IN STATE FUNDING TO SUPPORT NAVIGATION CENTERS

Investment will help bolster successful homelessness initiative

**San Francisco, CA** –Mayor Mark Farrell, California Assemblymember Phil Ting, and members of the Board of Supervisors today celebrated \$10 million in state funding to support the City's Navigation Centers.

The funding will help support two new Navigation Centers, to be located at 125 Bayshore Boulevard and Division Circle. On Tuesday, the Board of Supervisors voted to accept and expend the \$10 million in state funding for the future Navigation Centers.

"This critical funding allocation will provide us with new opportunities to build upon the successes of our Navigation Center system," said Mayor Mark Farrell. "Like Mayor Lee and

myself, Assemblymember Ting recognizes the effectiveness of our Navigation Centers. We will now have more opportunities to help people restart their lives and move into stable situations that best support their needs."

Assemblymember Ting secured the \$10 million in Housing and Community Development funds through his role as Chair of the California Assembly Budget Committee as part of the state's 2017-2018 budget, after Supervisor Hilary Ronen and Mayor Edwin M. Lee began discussions with him about the need for new Navigation Centers.

"Homelessness is a problem not just in San Francisco, but also throughout California," said Assemblymember Ting. "We know offering housing alone is not enough. Navigation Centers are an essential part of the equation because they provide critical support services to help homeless individuals off the streets long-term. By opening more Navigation Centers, we will have greater success in moving people out of tents and into housing. I'm proud to lead the effort in securing \$10 million in state funding to boost the City's investment in combatting chronic homelessness."

Navigation Centers create an entry point for people living in encampments who have not been able to engage in services through traditional shelters. The centers offer intensive case management and critical service connections to healthcare, entitlement benefits and drug treatment programs.

"The Mission neighborhood is experiencing a serious a public health crisis due to the drastic increase in the number of tent encampments," said Supervisor Ronen. "Navigation Centers work. They give homeless residents a chance at a new life, and they improve the cleanliness and safety of our streets. I will keep fighting to find out-of-the-box solutions to address street homelessness in my district and I'm so grateful to Assemblymember Ting for securing the funding and supporting me in these efforts."

"The homelessness crisis in San Francisco demands innovative solutions from everyone in the City," said Supervisor Malia Cohen. "The Navigation Center model offers not just a shelter, but builds wraparound resources and a path toward stability and building community. We are proud to partner with Assemblymember Ting for making this effort possible."

"The Navigation Center model has proven to be an innovative tool in addressing our homelessness crisis in San Francisco," said Assemblymember David Chiu. "The state has a role to play in supporting and expanding these programs."

Navigation Centers have a proven track record of moving people out of encampments and into stable living situations. The success of the Navigation Center system pioneered by San Francisco has made it a national model, replicated by other cities across the country.

"Navigation Centers are an important part of the City's larger homelessness response system," said Jeff Kositsky, director of the Department of Homelessness and Supportive Housing. "These new Navigation Centers will take their place alongside our other great programs that are focused on making a sustained and significant reduction in homelessness over time while working to create better outcomes for individuals and families."

# MAYOR MARK FARRELL, CALIFORNIA ATTORNEY GENERAL XAVIER BECERRA AND POLICE CHIEF WILLIAM SCOTT ANNOUNCE INDEPENDENT EVALUATION OF SAN FRANCISCO POLICE DEPARTMENT REFORMS

California Department of Justice to provide support following departure of U.S. Department of Justice decision to end Collaborative Review Initiative Agreements

**San Francisco, CA**— Mayor Mark Farrell, California Attorney General Xavier Becerra and Police Chief Bill Scott today announced that the California Department of Justice will collaboratively evaluate and report on ongoing reforms and the implementation of 272 recommendations at the San Francisco Police Department (SFPD).

This new agreement follows the decision by United States Department of Justice Attorney General Jeff Session to abandon collaborative effort with the SFPD to reform officer use-offorce policies, improve racial bias trainings, and enhance community policing, transparency and accountability efforts. "We made a promise to our residents and to our communities that we were going to transform our police department—and partnering with Attorney General Becerra will allow us to follow through on that pledge," said Mayor Farrell. "The SFPD has made measureable progress already, and the steps we have taken since the United States Department of Justice walked away have only strengthened our department. These reforms emphasize that every life is precious and every effort will be made to protect and defend our residents from harm. Our City is committed to making the SFPD a model law enforcement agency with the highest standards for accountability and transparency. I want thank the men and women of the SFPD for their commitment to reform. We are eager to see these efforts through with the help and partnership of the California Department of Justice."

"When local law enforcement agencies reach out for support, the last thing our federal government should do is abandon them," said Attorney General Becerra. "The California Department of Justice will stand with fellow law enforcement agencies that ask for vital assistance to promote trust, transparency and ultimately ensure public safety – both for our men and women wearing the badge and the communities they are sworn to protect. This agreement with the City and SFPD is critical for public safety. It serves as a prime example of state and local authorities collaborating in the absence of help from Washington."

In 2016, Mayor Edwin M. Lee asked the U.S. Attorney General Loretta Lynch and the United States Department of Justice (DOJ) to conduct a comprehensive review of the SFPD, with a specific focus on reforming use-of-force strategies.

The following year, the DOJ referred the request to the Office of Community Oriented Policing Services (COPS) and signed an agreement to outline multi-year agreements with independent monitoring teams to ensure a sense of accountability and to rebuild trust with communities. The COPS team identified 94 findings and 272 recommendations that emphasized the safeguarding of life above all else. Today, more than half of those critical reforms have been implemented or are in the approval process and as a result, use-of-force incidents dropped 18 percent in 2017.

However, the DOJ under the administration of President Donald Trump has reversed course on providing community-oriented policing assistance to local law enforcement agencies. Last September, Attorney General Sessions announced that the DOJ's COPS office would no longer collaborate with the SFPD on the reform process. When that occurred, conversations began between San Francisco and the California Attorney General to ensure that the reforms continued.

"These issues are personal for me," said Board of Supervisors President London Breed. "I have witnessed firsthand the consequences that stem from a lack of trust between our communities of color and law enforcement agencies. That is why I was one of the leaders who called upon the Department of Justice to provide an independent review of our Police Department which resulted in 272 recommendations. While our current Federal Administration may believe these collaborative approaches are no longer a priority, here in San Francisco we are not stopping. We are committed to these reforms and will continue to work with the California Department of Justice to advance them."

"Our residents need accountability, they need transparency and they need closure," said Supervisor Malia Cohen. "We will not abandon these critical reforms. Though the Federal Government has shown a lack of leadership, the State and the City are continuing forward for our community's safety. We will not give up until we restore trust between our law enforcement agencies and our communities of color."

"Our department and our San Francisco communities are witnessing the positive outcomes of Collaborative Reform," said San Francisco Police Chief William Scott. "Since we began this process, Use of Force has decreased 18 percent year over year and complaints against officers are down 8.5 percent. This collaboration with the California Department of Justice will reaffirm the independent evaluation of our work and provide the technical expertise necessary to help improve our police department. With the assistance provided by the California DOJ, the changes we are making will become long-lasting and embedded in our department culture."

Since the reform efforts began in 2016, the SFPD has completed 81 of the recommendations, submitted 79 others for review and begun the process on the remaining 112. The initiatives include the enhancement of existing policies that emphasize the safeguarding of human life, de-escalation techniques, and Crisis Intervention Team (CIT) training to respond to individuals experiencing mental or behavioral health crises. Additionally, leadership in the ranks has become more diverse, nearly tripling the number of women in leadership positions and more than doubling the number of minorities in leadership positions.

Other key accomplishments from the reforms include:

- Complaints to the Department of Police Accountability declined 8.5 percent in 2017.
- 819 SFPD members have attended the 40 hour CIT Certification course which provides trainees a set of tools to utilize in critical situations.
- The Department's Use of Force Policy was updated by the Police Commission following extensive discussion and public hearings.
- The Department's Training Division implemented mandatory Implicit Bias and Procedural Justice Training for all sworn members
- Use-of-Force reports are now published on a quarterly basis.
- All electronic communications via department owned devices (cellphones, email and patrol car terminals) are automatically screened for uses of biased language. Violations are automatically forwarded to Internal Investigations for follow up.
- Officer encounters with the public are now recorded with the Department's eStops app and reported on a quarterly basis.
- The Community Engagement Division has been restructured to provide a strategic and department-wide platform to enhance SFPD's community policing and outreach efforts.
- The Department relaunched the Community Police Academy to provide citizens with opportunities to learn about how officers operate and interact with the community.

Hello,

St. James Infirmary (SJI) is the first occupational safety and health clinic in the U.S. run by Sex Workers for Sex Workers. We offer free, confidential, nonjudgmental medical and social services for Sex Workers (current or former) of all genders and sexual orientations, and our clinic-based services are located in the Tenderloin.

San Francisco has long-since been recognized as a "progressive" city, with diverse communities and inclusive politics; however, over the past 5-10 years, many of us have observed and experienced rampant gentrification, that has left this city almost unrecognizable, and most certainly, unaffordable for a significant number of people who have called San Francisco home. The Tenderloin is known as one of the roughest neighborhoods in San Francisco, with high crime rates and a disproportionate number of individuals who are marginally housed or homeless, which unfortunately overshadows the rich history of the neighborhood and the unique experiences of the resilient residents, including families, artists, activists, and transgender individuals.

On a national level, there are significant efforts to annihilate the civil and human rights of women, people of color, immigrants, and transgender communities. Now, more than ever,

there is an urgent need for San Francisco to become a true "Sanctuary City" for all communities, and part of this movement includes creating cultural heritage districts in order to preserve the history of the communities that contributed to the various neighborhoods, and honor their integrity and vast commitments. Compton's Transgender Cultural District is an important initiative that will not only protect some of the most vulnerable communities and individuals, but will provide an opportunity for San Francisco to become a leader in demonstrating sustainable practices of formally acknowledging the cultural heritage of those who helped to shape and build magnificent cities.

According to the US Transgender Survey (2015-2016), **46%** of respondents were **verbally harassed** in the past year because of being transgender, **47%** of respondents were **sexually assaulted** at some point in their lifetime; and those who have done **sex work (72%)**, **experienced homelessness (65%)**, and **people with disabilities (61%)** were more likely to have been **sexually assaulted** in their lifetime. Yet, **57%** of respondents said they would **feel uncomfortable asking the police for help if they needed it**.

Nearly one-third (29%) of respondents were living in poverty – more than twice the rate in the U.S. population (14%) – and 30% had experienced homelessness at some point in their lifetime. The unemployment rate among respondents (15%) was three times higher than the unemployment rate in the U.S. population (5%), with people of color experiencing higher rates of unemployment. Overall, 30% of respondents who had a job in the past year reported being fired, denied a promotion, or experiencing some other form of mistreatment related to their gender identity or expression.

And, perhaps the most heartbreaking finding was that **40%** of respondents have **attempted suicide** in their lifetime—nearly nine times the attempted suicide rate in the U.S. population **(4.6%)**.

While it may be convenient to dismiss national statistics and trends, it is important for San Francisco to recognize the parallels with regards to discrimination and the impact of stigma, and strive towards providing a safe environment for all transgender communities and individuals to live and work in. Acknowledging the meaningful social and political work of transgender communities and individuals who resided/congregated in the Tenderloin, and enacting cultural heritage districts, is an important first step in adequately preserving the lineage of those who were here before us. Honoring the efforts of particular communities does not equate to excluding others; rather, it creates opportunities to highlight historic movements and educate the general public. From a fiscal perspective, this translates to increased tourism in the Tenderloin, with visitors coming to the area to learn more about the Compton's Cafeteria Riot. While conventional history lessons have typically left out the transgender heroes who stood up to violence 50 years ago, San Francisco can properly acknowledge their bravery through the implementation of Compton's Transgender Cultural District.

We must acknowledge that there are many communities throughout San Francisco that deserve recognition, and that the most vulnerable populations should be prioritized in terms of protective measures when discussing city-wide development plans and programming. San Francisco has previously protected historical buildings and monuments, but by creating cultural heritage districts in designated areas, we can ensure that community members themselves (not just legislators and/or developers) are part of the process, and preserve

the richness of this city before it continues to fade away.

Thank you for your letter dated December 6, 2017 and my apologies for the late response. Occasionally, a <u>landmark designation ordinance</u> will provide clarity on the review process for scopes of work that generally do not require a Certificate of Appropriateness or a building permit to complete. In reviewing the landmark designation ordinance for the subject property, and the Planning Code, we are unable to locate any specific requirements for the maintenance of the communal garden and hedge. There may be private agreements between both properties regarding maintenance and upkeep. The Planning Department and the Historic Preservation Commission would not be parties under such agreements. I'm available should you have further questions.

Annual homicides in San Francisco have dropped 42 percent from a decade ago

**San Francisco, CA**—Acting Mayor London Breed today announced that San Francisco's homicide tally in 2017 dropped from the year prior and marked a 42 percent decrease from totals recorded a decade ago.

"One death on our streets is too many," said Acting Mayor Breed. "I have lost friends and families to senseless violence, and I know firsthand that the pain from these incidents never truly heals. But by working closely with our most impacted residents, we are building the foundation for safe, healthy communities for generations to come. Together, we can break these endless cycles of violence."

"I know what it is like to lose friends and family members to senseless violence," said Acting Mayor Breed. "No one should ever have to experience that, which is why I am committed to improving public safety in our city. One death on our streets is too many. But by working

closely with our most impacted residents, we are building foundations for safe, healthy communities for future generations."

San Francisco recorded 56 homicides in 2017, down from 58 in 2016. The totals are a dramatic reduction from 10 years ago, when there were 96 homicides in San Francisco. San Francisco's 6.4 homicides per every 100,000 residents is one of the lowest rates in the nation among major cities, according to data from 2016, the most recent year collected by the FBI.

Acting Mayor Breed announced the drop in homicides at the Potrero Hill Recreation Center alongside Supervisor Malia Cohen, San Francisco Police Chief Bill Scott and community members engaged in the revitalization and activation of parks as part of the City's HOPE SF initiative.

The recreation center is a participating site in the City's Peace Parks collaboration, a community wellness and violence prevention partnership between youth residents, the San Francisco Police Department (SFPD), the Department of Public Health (DPH), and the Recreation and Park Department.

"Today, we proudly celebrate this investment of resources," said Supervisor Malia Cohen. "High-quality wellness programs and recreational activities have transformative long-term impacts on children, families and communities. This is a promising glimpse into the future health of our city."

The Peace Parks program supports underserved communities by offering safe spaces for healthy recreation while providing opportunities for residents to build relationships with local law enforcement members. Police officers familiar with the neighborhoods from local district stations are assigned to each site to partner with community members and Recreation and Park staff, providing a safe and inclusive space for park visitors of all ages.

"Our City's parks are an important community resource," said Police Chief William Scott. "Our goal is to bring families together to enjoy creative, fun programs and get to know their neighborhood-based officers in a safe, productive environment. When our City agencies team up with community members to provide opportunities for youth, the potential is unlimited."

Peace Parks is offered at the Herz Clubhouse and Playground in Visitacion Valley, Youngblood Coleman Clubhouse and Playground in Bayview Hunters Point, and the Potrero Hill Recreation Center. SF Rec and Parks creates the programming and officers from SFPD engage with the participants as part of the collaborative effort.

"Through the Peace Parks collaboration we are able to offer different programs that are of interest to teenagers, young adults and families, all while building relationships in the community." said Phil Ginsburg, Recreation and Park Department's General Manager. "The participation of the Police Department helps us ensure that everyone has access to healthy recreation in all our parks at all times."

Peace Parks is a key component of the SFPD's community policing strategy. It is one of several community efforts to complement the City's HOPE SF initiative, a comprehensive commitment to replace and transform San Francisco's public housing communities into vibrant, mixed-income communities without displacement of existing residents.

The Peace Parks programming focuses on exercise, nutrition, job readiness and creative recreation outlets, and is developed based on each community's unique needs. Programs include General Education Diploma (GED) courses, job and skills training and classes related to dance, nutrition education, cosmetology, boxing and disk jockey skills. The Peace Parks program is funding by the City's General Fund with an annual budget of \$648,447, serving as many as 300 individuals a month.

To remove any registration and administrative challenges, recreational programming is offered on rolling basis, every Thursday through Saturday from 6 p.m. to 10 p.m. The program operation hours are selected to meet the recreation demands when many young people do not have many options for fun and healthy recreation programming.

City to fund development of a business plan and stakeholder engagement process for potential modular housing production facility

**San Francisco, CA** – Acting Mayor London Breed and San Francisco labor groups today announced a new partnership effort aimed at creating well-paying jobs while increasing housing opportunities for local residents.

In collaboration with local labor unions, the City will create a business plan and fund a stakeholder engagement process for the development of a modular housing production facility in San Francisco. Modular construction is a method in which building components are built offsite and then transported to a construction site for quick assembly. The modular units created at this San Francisco facility will primarily be used for residents experiencing homelessness.

"The housing shortages and homelessness issues facing our city are the challenges of our time, and we need to deliver creative solutions," said Acting Mayor Breed. "It is clear that we need

more housing and we need it now. With this initiative, we are taking bold new steps to build homes in a timely, efficient manner while continuing to create strong union jobs for our residents."

"I want to thank former Mayor Ed Lee and current Mayor London Breed for recognizing building trades workers and the importance of keeping these jobs in San Francisco," said Larry Mazzola Jr., President of the San Francisco Building and Construction Trades Council. "Fixing the homeless problem, along with the housing shortage in San Francisco are two major issues that San Francisco faces, and we are proud to partner with the City to help develop a facility that addresses these issues while keeping jobs in our local economy."

"We see a real opportunity in this for pathways into good careers for San Francisco residents," said Michael Theriault, Secretary-Treasurer for the San Francisco Building and Construction Trades Council. "Our gratitude is with the late Mayor Lee and we look forward to a highly productive partnership with Mayor Breed."

The City will seek a consultant with substantial experience in the design, construction and operation of modular housing production facilities that can both develop a business plan and facilitate the stakeholder process. Funding for the consultant will come from the Mayor's Office of Housing and Community Development (MOHCD) and Office of Economic and Workforce Development (OEWD).

"We are very excited about the prospect of creating more permanent, quality union jobs while also producing affordable housing faster and more cost-effectively," said MOHCD Director Kate Hartley. "We are optimistic that this exploratory effort will result in a great win for all San Franciscans."

"We have made growing and retaining good manufacturing jobs a priority in San Francisco," said OEWD Director Todd Rufo. "This funding is an important first step in developing a facility in partnership with labor that creates good jobs and accelerates affordable housing."

The project will have two phases. The first phase will consist of the consultant's facilitation and leadership of a series of meetings with San Francisco City staff and labor sector partners regarding the construction and long-term operation of a modular housing production facility. The meetings will explore the broad components essential to a facility's creation, including capital investment requirements, construction specifications, site logistics, transport requirements for raw materials and finished components and staffing levels, among other details.

In the second phase of the project, the consultant will develop a business plan for a modular housing production facility in San Francisco using the Phase 1 process to inform its development. MOHCD and OEWD will finalize recommendations for Acting Mayor Breed by the end of the year.

Hello Commissioner Wolfram,

I am following up on the HPC's request to sync the Legacy Business Registry quarterly report with the Cultural Heritage report. Per Rick Kurylo's email below, there is typically a delay of a few weeks between when our quarterly reports are sent to the HPC and when the LBR report is ready. It seems to me that there are 4 options to resolve this:

- 1. Keep our typical Cultural Heritage report dates, and delay reporting the LBR by one quarter, so the 1<sup>st</sup> quarter data would be reported at the end of the 2<sup>nd</sup> quarter, etc.
- 2. Delay our Cultural Heritage report by a few weeks so that it can capture the LBR data.
- 3. Explore capturing and reporting the LBR data directly from OSB's records, rather than relying on Rick's report.
- 4. Maintain status quo and deliver two separate reports to the HPC the Cultural Heritage Report and the LBR Report.

Process formally begins to provide fast and affordable internet access for all San Franciscans

**San Francisco, CA**—Mayor Mark Farrell, the City Administrator's Office and the Department of Technology today announced that the City will begin the process of bringing a citywide fiber network to San Francisco that will prioritize net neutrality and privacy protections and deliver fast and affordable internet.

"Trump's hand-picked FCC and Republicans in Congress have dismantled crucial net neutrality, privacy, and consumer protections," said Mayor Farrell. "We will provide an alternative that favors the general public and San Francisco values, not corporate interests. Through this project, we will close the digital divide, ensure net neutrality, and create a truly fair and open internet in San Francisco."

Today, a Request for Qualifications (RFQ) was issued seeking teams capable of designing and delivering a <u>citywide fiber network</u> to San Francisco. The fiber network will provide universal internet coverage in San Francisco and is a transformative effort to provide affordable, high-

quality internet service for all.

"Today marks a major step forward in delivering affordable municipal fiber aligned with San Francisco's values of net neutrality and digital inclusion," said City Administrator Naomi Kelly. "San Francisco remains committed to ensuring every household has access to fast, reliable internet service."

Any internet service provider using San Francisco's network will be required to follow strict net neutrality protections, including commitments to transparency, the free flow of information, equal treatment of traffic, no paid prioritization and unobstructed access to lawful websites. Additionally, any internet service provider must follow robust privacy and security standards.

The guidelines offer a stark contrast to the standards of the Trump administration, which has repeatedly rolled back popular net neutrality and privacy protections, allowing personal internet use to be dictated by the highest bidder.

"We encourage bidders to submit their qualifications and explain their approach for partnering with the City to serve all San Franciscans with affordable, high speed internet service" said Linda Gerull, City Chief Information Officer for San Francisco. "This infrastructure investment will provide new opportunities for businesses and residents as well as enable future City services".

The fiber network is being designed to ensure that low-cost, high-speed internet is available for all, helping to eliminate the digital divide in San Francisco. Currently, 12 percent of San Francisco residents—approximately 100,000 people—lack internet access at home. About 15 percent of the City's public school students do not have internet access, a number that increases to 30 percent for African American and Latino students. The cost of internet services has been repeatedly cited as a barrier to access for low-income families.

The RFQ being issued today is seeking bid teams capable of designing, building, operating, financing and maintaining a citywide fiber optic network. Last year, City officials met with industry leaders to gather feedback on the plan to create a robust citywide fiber network.

The RFQ process will identify 3-5 qualified groups by the end of April. Following that, the City will issue Request for Proposals (RFP). The bidding team that is awarded the contract will build, operate and manage the City's open access fiber optic network for 15 years.
