

<u>59 POTOMAC STREET</u> – Located on the west side of Potomac Street between Waller Street and Duboce Park, Assessor's Block 0865, Lot 008 (District 8). Request for **Certificate of Appropriateness** for a revision to a previously-approved Certificate of Appropriateness to enclose an 87 sq. ft. deck at the rear façade's third story. The wood frame Queen Annestyle building was constructed c. 1905 by an unknown architect and is a contributor to the Duboce Park Landmark District and is located within a RH-2 (Residential-House, Two-Family) Zoning District and 40-X Height and Bulk District. *Preliminary Recommendation: Approve with Conditions* **Continued to December 18, 2019**

<u>55 HAGIWARA TEA GARDEN DRIVE -MUSIC CONSCOURSE, GOLDEN GATE PARK</u> – Located between John F. Kennedy Drive, Hagiwara Tea Garden Drive, Martin Luther King Jr. Drive, and Music Concourse Drive. Lot 001 in Assessor's Block 1700 (District 1). Request for a **Certificate of Appropriateness** to install new lateral irrigation for the ongoing maintenance of the grid of pollarded trees in the Music Concourse Bowl. The Music Concourse, Landmark No. 249, is individually significant as an outdoors performance space important in San Francisco's cultural history and as an urban park landscape devoted to public performances and as a setting for public art. The subject property is located in a P (Public) Zoning District and an OS Height and Bulk District.
