#### **Marcelle Boudreaux:**

This is Marcelle Boudreaux, Department Staff. I would like to provide an update on the UCSF Parnassus MOU and EIR on behalf of the Department. Tomorrow there will be in Informational on the UCSF MOU at the Planning Commission. The agencies involved in working with UCSF to draft the MOU include: the Planning Department, MTA, the Mayor's Office, Department of Public Health and Office of Economic and Workforce Development. As a reminder, on August 19, 2020, the HPC provided comments on UCSF draft EIR and recommended landmarking of the Bernard Zakheim murals. The MOU did not specifically address the murals, but it is our understanding that the EIR will include the following mitigation. UCSF will convene a Task Force by the end of 2021 to advise on options for the display of the History of Medicine murals in a publicly accessible setting. Either on a UCSF campus, or a museum, or other institution. The Task Force will include the chair of the City's Historic Preservation Commission or their designee. As a reminder also, I think we have provided this update in October 2020. UCSF bid contracts with the Historic Preservation contractor to begin work on safely removing and storing murals for future relocation. Because preservation of the murals is included as a mitigation in the EIR, there – it was determined there was not a need to duplicate this measure in the MOU. Any questions about the process and organization of the mural advisory committee to be addressed directly to UCSF and Department staff can help coordinate a meeting with the appropriate people there. The timeline for next steps includes - a third community meeting by UCSF about the MOU this evening; a link to participate either has been or will be mailed to Commissioners; an Informational Presentation at the Planning Commission as noted is scheduled tomorrow, January 7th; and a discussion at the Board of Supervisors is anticipated in the next week. The details of which are still being determined. The UC Regents are meeting on January 20, 2021 to approve to EIR. They are not, however, reviewing or approving the MOU. The MOU will be signed by directors of the City agencies who have been participating and the University Chancellor in February. That's the end of my updates. Thank you.
