In response to 'large developments' Supervisor Mandelman has developed a new **Legislative Section 319 Large Residence Developments** that states, "The purpose of this Section 319 is to protect and enhance existing neighborhood character, encourage new infill housing at compatible densities and scale, and provide for thorough assessment of proposed large single-family residences that could adversely impact neighborhood character and affordable housing opportunities."

It will require all RH properties to get a Conditional Use Authorization for any unit with a gross sf over 2,500sf, and for any expansion 10% of the gross sf of all development done in the last 10 years.

I am not supporting this legislation based on the negative impact it will have

1. It adversely changes the intent of zoning laws that typically use form-based regulations, i.e yards, setbacks, and height limitations to determine what can be developed allowing for the variety of lot conditions and sizes to create a rich diverse urban fabric.

- 2. It will add time and expense.
- 3. It will add workload for Planning Staff and Commissioners to a system overburdened with

Conditional Use Authorizations.

- 4. It will not encourage density or create affordable housing.
- 5. It will not discourage large construction.

I propose these alternative suggestions to address Mandelman's concerns

1. Change the definition of area used in calculations to exclude the square footage of unoccupied ground floor and attic spaces, exterior walls, parking, and mechanical rooms.

2. Allow units to expand without CUA on a sliding scale proportional to their current size:

- • Eliminate expansion limits resulting in units equal to or less than 3,000 sf .
- · Allow 50% expansion of units between 3,001 3,500 sf
- • Allow 25% expansion between 3,501 4,000 sf
- · Allow 15% expansion between 4,001 4,500 sf
- · Allow 10% between 4,501 sf and over

3. Do not include in the calculation of allowable % increases "all development performed on the lot within the last 10 years" before these restrictions even existed.

4. Do not include in the regulations and criteria for Findings for a CUA criteria that are already regulated by Planning in existing regulations and processes

5. Grandfathering: Change the applicability of the ordinance to instances where a complete Development Application is submitted after *the effective date of the legislation* rather than the date legislation was introduced (February 2, 2021).

### I support efforts to:

- 1. Allow housing to adapt to accommodate the diverse community that occupies the **B**ay Area
- 2. Provide life and health safety measure and seismic upgrades
- 3. Adapt Sustainability and Energy Conservation methods
- 4. Encourage up-zoning to allow for density

Proposal would provide an opportunity for 200+ permitted venues, bars, restaurants, and other businesses to sustain their outdoor entertainment and amplified sound activities beyond the pandemic

**San Francisco, CA** — A temporary live music program started during the pandemic would be made permanent under pending legislation introduced by Mayor London N. Breed. Building off the success of the Just Add Music (JAM) Permit program, which has allowed businesses to offer safe and accessible outdoor entertainment, the permanent program will provide small businesses additional space to host local entertainers.

"Entertainment and the arts are an important part of our City's economy and culture," said Mayor Breed. "Thanks to the work of the Entertainment Commission, this program provided a lifeline for our artists and musicians to survive through the pandemic, and brought life back to our communities. As our City recovers, we need to do everything we can to support our small businesses and local entertainers, including making our Shared Spaces program permanent and passing the Small Business Recovery Act, which will provide an opportunity for outdoor locations to continue offering entertainment after the pandemic."

Launched in September 2020, in response to the need voiced by the small business and arts community, the Entertainment Commission administered the JAM Permit program to help

businesses, organizations, and individuals hold responsible entertainment activity at Shared Spaces and other outdoor locations. The temporary program provides a free streamlined pathway for the arts, entertainment, and nightlife sectors to support their business livelihoods by adding music and other cultural activity. In addition, the JAM program facilitated creative solutions to support businesses attract customers, backfill lost revenues, and employ local artists and entertainers throughout the COVID-19 pandemic.

"The JAM permit program has been a successful intervention to help our struggling entertainment and nightlife industry weather the pandemic with safer outdoor activity, and to keep our neighborhoods vibrant with arts and cultural experiences during a tremendously isolating time," says Maggie Weiland, Executive Director of the Entertainment Commission. "By transitioning these permits to permanent outdoor entertainment spaces, we are increasing the industry's capacity for long-term recovery and success."

Since its launch, the JAM program has received a high level of participation from small businesses and has issued 250 permits at outdoor locations, including 200+ businesses with daily or weekly entertainment and amplified sound activity. Restaurants (55%) and bars (33%) make up 88% of permits issued, with 11% of businesses identifying as live music venues and nightclubs.

"As a small business owner, I had to reinvent myself throughout the pandemic constantly," said Aurore Martinez, Owner and Founder of Cocotte. "The JAM permit, along with the Shared Spaces program, allowed me to maintain a successful business and bring new life and color to the neighborhood. The joy that comes with providing live music and outdoor gathering space is a constant reminder of why I opened my restaurant, and it reaffirms my love for this City."

"The JAM permit has allowed the SOMA Pilipinas Arts and Culture Community to jumpstart our recovery," says Desi Danganan, Executive Director of Kultivate Labs. "We've been able to transform an abandoned City parking lot into a vibrant garden and performance space that draws all sectors of our community from punk bands to seniors to gather safely outdoors. The crowds that come to Kapwa Gardens to enjoy music and performances has created additional opportunities for vendors to sell food and accelerate our economic recovery."

The JAM Permit program is currently tied to the declaration of a local state of emergency due to COVID-19 and is set to expire December 31, 2021. Under the permanent proposal from Mayor Breed and the Entertainment Commission, eligible businesses with existing JAM permits will have the opportunity to transfer their outdoor permit to brick and mortar locations or transfer the use for a one-time event. All transfer applicants must comply with standard public noticing, neighborhood outreach, and public meeting requirements.

The JAM Permit aligns with and enhances San Francisco's Shared Spaces program by creating a pathway for businesses to add safe, vibrant cultural activity to outdoor dining and retail spaces. Launched in June 2020, Shared Spaces allows neighborhood businesses to share a portion of the public right-of-way, such as sidewalks, streets, or other nearby public or private spaces for dining and retail activity, as allowed by San Francisco's Public Health Order. Due to widespread success, on March 12, Mayor Breed announced legislation to transition Shared Spaces from an emergency response into a permanent program through and after the pandemic.

Both Shared Spaces and the JAM Permit program were essential lifelines for San Francisco small businesses and local entertainers throughout the pandemic and, will play a key role in our City's economic recovery.

"I applaud Mayor Breed for supporting this critical next step in recovering our industry for years to come," says Ben Bleiman, President of the Entertainment Commission. "This plan is potentially transformational for small businesses and artists as it gives them an unprecedented opportunity to increase revenue and reach larger audiences."

"By making outdoor entertainment activities possible, the JAM Permit program opens the door to economic recovery for San Francisco businesses and our local artists," says Kate Sofis, Director of the Office of Economic and Workforce Development. "The arts have been essential to comforting residents during the pandemic and now that we're open, music and entertainment are sure to create opportunities for lively community engagement that bolsters the vibrancy of our neighborhoods. The JAM program provides local establishments and our performing artists the flexibility they need to thrive."

"Being able to easily obtain a permit to have music through the JAM program makes our events so much easier to produce," says Cal Callahan, District Manager of the LEATHER & LGBTQ Cultural District. "Having music creates a festive atmosphere and attracts additional passersby as we have seen at our SOMA Second Saturdays! art and artisans events. This is essential to achieve our goals of providing artists and artisans a place to sell their wares while bringing more business to local restaurants, bars, and shops. We hope the program continues into the future as we expand the number and scale of outdoor events that we create and promote."

The Small Business Recovery Act and Shared Spaces legislation that Mayor Breed introduced will make the program permanent allowing residents, businesses, and organizations to continue enjoying outdoor entertainment at their favorite small business. Additionally, the permanent program creates a clear path forward for new JAM Permit applicants and makes several programmatic adjustments to ensure equity and inclusion, and maintain accessibility and public access.

Multi-pronged approach consists of plans to increase housing subsidies and create additional affordable housing units for people living with HIV/AIDS

**San Francisco, CA** — Mayor London N. Breed today announced the City has published its HIV/AIDS Housing Five-Year Plan. The final plan is the result of four City departments, led by the Mayor's Office of Housing and Community Development (MOHCD), who have partnered to produce a path forward that ensures people living with HIV/AIDS (PLWHA) receive quality housing services that support the best possible housing outcomes.

The goals of the five-year plan include maintaining current housing and facilities, increasing new housing units, increasing resources for subsidies, expanding access to resources, and improving the efficiency and quality of the housing and service delivery ecosystem. This plan would result in a total increase of the number of rental subsidies dedicated to PLWHA by 30% within the next 5 years, and expansion of the overall number of PLWHA served through MOHCD's HIV housing service programs by 30%.

"San Francisco has been a national leader in our response to the HIV/AIDS epidemic and in our efforts to get to zero new infections, and we know part of our success in helping people live healthier lives is to ensure they have access to housing," said Mayor Breed. "This plan is part of our commitment to strengthen housing stability and access for our most vulnerable residents, including those living with HIV/AIDS."

"Stable housing is vital to the health of San Franciscans living with HIV/AIDS. The expansion of housing options for HIV-positive people proposed in this plan will save lives and move us closer to our Getting to Zero goals of no new HIV infections, no new HIV-related deaths and no HIV-related stigma," said Supervisor Rafael Mandelman.

San Francisco is home to one of the largest communities of PLWHA in the nation, and it has been proven that providing housing stability to vulnerable communities results in improved health outcomes. The HIV/AIDS Housing Plan details how HIV housing services within San Francisco have evolved over the last few years; describes where services are progressing that improve housing systems, better meeting the needs of PLWHA; and highlights various goals and strategies the City is seeking to achieve and employ in order to improve access to housing services for PLWHA over the next five years.

"The plan gives us the framing and guidance needed to ensure that our office is responsive to the needs of residents living with HIV/AIDS," said Eric Shaw, Director of the Mayor's Office of Housing and Community Development. "MOHCD will continue to approach this effort in a manner that is resident centered, and in collaboration with city agencies and community partners."

"The HIV Housing Plan unites Medical Professionals, Community Based Organizations and Housing Partners," said Dr. Monica Gandhi, Professor of Medicine, UCSF and Medical Director of Ward 86 and Erin Collins, LCSW, Ward 86 at San Francisco General Hospital. "The robust approach maximizes the care, advocacy, and coordination required to reduce stigma, increase prevention, and enhance engagement of ongoing treatment for PLWH."

The City also recently announced the <u>development teams for nine new 100% affordable</u> housing sites, adding nearly 900 homes to MOHCD's construction pipeline. Building and developing these new homes is a key pillar of the Mayor's COVID-19 recovery strategy and will be crucial to revitalizing the City's economy while addressing the community's need for new housing. Each of the nine sites will have units available for referrals from the City's Plus Housing list for low-income residents living with HIV with rents set at no more than 50% AMI (\$1,166 for a studio, \$1,333 for a one bedroom).

"In order for the City of San Francisco to meet our ambitious goals of Getting To Zero, we need to address the housing crisis for people living with HIV/AIDS," said Bill Hirsh, Executive Director of the AIDS Legal Referral Panel. "We are pleased that this new award will significantly advance those goals by creating new affordable housing for people living with HIV. Housing is healthcare for people living with HIV."

"As a pioneer in HIV/AIDS services dating back to the 1980s, Catholic Charities has been a part of and witness to the dramatic transformation of care for those living with HIV/AIDS in our community," said Jilma L. Meneses, Catholic Charities Chief Executive Officer. "San Francisco's new HIV/AIDS housing plan reflects the advances in care that now enable individuals to live independently with more freedom and better long-term outcomes."

HUD's Housing Opportunities for Persons with AIDS (HOPWA) Program is the Federal funding source for most HIV housing services in San Francisco. HOPWA is transitioning to a formula-based funding model based on incidence of new HIV infection rather than the

historical model based on cumulative AIDS cases. Due to San Francisco's innovative HIV/AIDS healthcare programs that have led to the sustained decrease in the number of new HIV infections, the City will be looking to support ongoing programming by obtaining alternative funding. ## SS Jeremiah O'Brien

Tomorrow, July 2, the SS Jeremiah O'Brien will re-open to the public ahead of the Fourth of July celebration. A living museum on the National Register of Historic Places and a National Historic Landmark, he SS Jeremiah O'Brien is one of two remaining fully functional Liberty ships launched during World War II. Moored at Pier 45, Fisherman's Wharf, she is a premier San Francisco attraction.

## San Francisco Fleet Week

San Francisco Fleet Week is slated to return this year from October 3-11 with the return of the Air Show, the Parade of Ships, the humanitarian village and joint military and civilian disaster planning exercises.

San Francisco Fleet Week is an annual event that began in 1981 with a celebration of America's Sea services led by then-Mayor Dianne Feinstein. Fleet Week takes place in early October each year to honor the men and women of the United States Armed Forces, and to enhance cooperation and the sharing of knowledge between civilian and military humanitarian assistance personnel.

The City will fund child care providers and educational programs to help minimize the impacts of the COVID-19 pandemic on San Francisco's youth

New case study released today on Community Hubs Initiative, which provided support for youth during school closures, will provide guidance in how City supports youth and families in the fall and beyond

**San Francisco, CA** — The City budget proposed by Mayor London N. Breed and recently agreed to by the Board of Supervisors includes an investment of \$15 million in one-time funding to address student learning loss and education recovery for San Francisco's children and youth. Building on the City's investment of over \$100 million for Emergency Child and Youth Care Centers, the Community Hub Initiative, and the Summer Together Initiative, the City will use the new investment to help mitigate learning loss resulting from the COVID-19 pandemic and expand academic support, which includes high dosage tutoring, social emotional learning and literacy programs.

The San Francisco Unified School District (SFUSD) is currently studying the impacts COVID-19 had on the development of San Francisco's youth. Once staff has completed their assessment and identified which areas of learning were significantly impacted, the \$15 million Mayor Breed and the Board of Supervisors have agreed upon will be allocated accordingly.

Areas of learning and development being studied include high-dose tutoring, social-emotional learning, and literacy.

"With the significant investments in education we made last year, we knew that it was critical for our City's most vulnerable students to have the necessary resources to excel during the pandemic," said Mayor Breed. "As students prepare for a fall return to the classroom, it is more important than ever to continue investing in their education and continue working to close the widening achievement gap. I want to thank DCYF, the Recreation and Park Department, the Library, and our community partners for all the work they have done to support San Francisco students throughout this past year."

"As a lead author of the SF RISE initiative and a public school parent myself, I am painfully aware of the toll that school closures have had on the overall well-being of students, especially students from low-income and immigrant families who have been disproportionately impacted by COVID-19," said Supervisor Hillary Ronen. "This \$15 million investment by the Mayor's office will help jumpstart our efforts to aggressively expand enrichment and academic success services for students and families in SFUSD, and stem the educational and mental health impacts that students endured under distance learning. SF RISE is an ambitious undertaking that will require continued investment from local and state government and our philanthropic partners, but one that we must achieve if we are to do right by our children, educators, and families."

"This significant investment will expand the data-proven success of the community-school model across San Francisco. If we took away anything from the past 15 months, it is that nothing is impossible with swift thinking, creativity, and collaboration. We must not only restore what was lost academically, but ignite our children's love for learning again through educational support, arts and recreation, and wrap-around services not just for the well-being of our students, but their families as well. This is the vision we hope to achieve with the Students and Families RISE Workgroup we established earlier this year with a collective strategy to bring all students to grade level, attract families back to our public schools, and strengthen community-based enrichment for our schools," stated Supervisor Myrna Melgar.

Since the Shelter in Place Order was put into effect in March 2020, Mayor Breed has invested over \$100 million to provide free programs to support children, youth, and families. These efforts have included emergency child and youth care centers for frontline and essential workers, in-person support for students enrolled in remote learning programs, and free summer camp programming for SFUSD students.

The City's efforts to support children, youth, and families through the COVID-19 pandemic is the focus of a new case study, *Showing Up While Everything Is Shutting Down: A Story of Cooperation in San Francisco*, released today by the San Francisco Education Fund. The study explores the City's Community Hubs Initiative, particularly the local context that made this unconventional, cross-sector partnership possible. Additionally, the study examines the barriers the Initiative had to overcome including public health restrictions, political resistance, and structural limitations, and highlights lessons learned and main drivers of success, such as: bold and lane-changing leadership; true collaboration; and hidden heroes: youth development professionals.

Pulling testimonies and learnings from a diverse group of stakeholders, the over-year-long case study offers a model for how communities might rethink the role of governments,

nonprofits, and educational institutions to truly meet the needs of the families at their center, in crisis and beyond.

The Community Hubs Initiative, which provided in-person support for distance learning and out of school time activities for San Francisco's highest needs children and youth, served nearly 3,000 students at 78 locations throughout the City, successfully completing the 2020-2021 school year. The Department of Children, Youth and Their Families, Recreation & Parks, San Francisco Public Library, San Francisco Unified School District, community partners, and the private sector joined the Mayor's call to action to ensure our City's most vulnerable students continued to have the support and resources they needed to learn, grow, and thrive during the COVID-19 pandemic.

"Thank you, Mayor Breed for your commitment to our children's unfinished learning," shared SF Department of Children, Youth and Their Families Executive Director Maria Su. "As our City's families struggle with the long-term implications of distance learning, students will need a lot of services and supports to get them back on track towards success. We will expand individualized tutoring opportunities, bring on more youth development professionals to support them in the out of school time hours, and create wrap-around support for students and families as they navigate this coming year."

"The SF Ed Fund is proud to partner with the City and our community agencies and shine a light on the Community Hub Initiative through this case study. It's clear our community has the will and agility to prevent additional unfinished learning for our youth," said SF Education Fund CEO Stacey Wang. "San Francisco now has the knowledge to make our education systems more resilient while staying safe, and our case study can serve as a blueprint for other cities across the country aspiring to align their education efforts."

"The pandemic was a crash course in helping families during a crisis. We had to be fast and we had to be creative—there was simply no time for bureaucracy," said San Francisco Recreation and Park Department General Manager Phil Ginsburg. "We were able to transform our rec centers into emergency childcare facilities and Community Hubs and offer free summer camps to public school students thanks to the support of Mayor Breed and an extraordinary spirit of collaboration across sectors. This report captures the lessons learned and will prove indispensable as The City continues its investment in our children."

"San Francisco Public Library is proud to have been a part of this extraordinary initiative by hosting ten hubs at neighborhood branch libraries located near communities that were disproportionately impacted by COVID-19," says City Librarian Michael Lambert. "Even though we are transitioning these sites back to regular library service, we are still here to support the youth and families of this city with an abundance of free, year-round educational resources and access to wifi and other technology."

It was found to be beyond the scope of the permit but with corrections to the Demolition Calculations of Section 317 it was abated and is still considered an Alteration.

The original house is a contributor to Raycliff Terrace...see the notation from the SFPIM below on the historical importance of Raycliff Terrace.

This house is a Second Bay Tradition designed by H.O. Baumann who is noted for his many fine apartment buildings throughout Pacific Heights and this was one of the few single family homes he designed in San Francisco according to the HRE on the SFPIM.

I am not supporting this legislation based on the negative impact it will have

1. It adversely changes the intent of zoning laws that typically

use form-based regulations, i.e yards, setbacks, and height limitations to determine what can be developed allowing for the variety of lot conditions and sizes to create a rich diverse urban fabric.

- 2. It will add time and expense.
- 3. It will add workload for Planning Staff and Commissioners to a
- system overburdened with Conditional Use Authorizations.
- 4. It will not encourage density or create affordable housing.
- 5. It will not discourage large construction.

I propose these alternative suggestions to address Mandelman's concerns

1. Change the definition of area used in calculations to exclude the square footage of unoccupied ground floor and attic spaces, exterior walls, parking, and mechanical rooms.

- 2. Allow units to expand without CUA on a sliding scale proportional to their current size:
- · Eliminate expansion limits resulting in units equal to or less

than 3,000 sf.

- · Allow 50% expansion of units between 3,001 3,500 sf
- · Allow 25% expansion between 3,501 4,000 sf
- · Allow 15% expansion between 4,001 4,500 sf
- Allow 10% between 4,501 sf and over

3. Do not include in the calculation of allowable % increases "all

development performed on the lot within the last 10 years" before these restrictions even existed.

4. Do not include in the regulations and criteria for Findings for a

CUA criteria that are already regulated by Planning in existing regulations and processes

5. Grandfathering: Change the applicability of the ordinance to

instances where a complete Development Application is submitted after the effective date of the legislation rather than the date legislation was introduced (February 2, 2021).

I support efforts to:

1. Allow housing to adapt to accommodate the diverse community that occupies the Bay Area

- 2. Provide life and health safety measure and seismic upgrades
- 3. Adapt Sustainability and Energy Conservation methods
- 4. Encourage up-zoning to allow for density

This proposed legislation must be amended to be effective.

Dear Colleagues:

I write in response to inquiries I have received from some of the commission secretaries asking when commissions will be permitted to resume in-person meetings in City Hall, in light of recent changes in workplace safety regulations and Health Order restrictions.

Timing for the Resumption of In-Person Meetings in City Hall with In-Person Public Comment: Inperson board and commission meetings in City Hall with some or all in-person public comment will not return until this September. This aligns with the timing of full Citywide office reopening at new prospective regular in-person staffing levels consistent with City policies, and the return of in-person public comment at the Board of Supervisors. Please note that this is what I understand to be the plan as of today; this may change depending on the circumstances and further policy decisions.

<u>Timing for the Resumption of In-Person Meetings in City Hall with Remote-Only Public Comment</u>: I am unable at this time to provide you with a precise date as to when in-person commissioner/board member/staff-only meetings will be permitted to resume in City Hall. By virtue of orders issued last year, all boards and commissions (other than the Board of Supervisors) are currently prohibited from meeting in person except for in-person discipline hearings with the Mayor's consent. Note that this prohibition applies irrespective of where the meeting is to be held, whether in City Hall or elsewhere.

We do not yet know when the Mayor and/or the Board will terminate the order prohibiting in-person meetings, but I will let you know when we have more information on that. In the meantime, please consult with your designated Deputy City Attorney if you believe there is a disciplinary matter before your commission/board that may meet the disciplinary hearing exception.

Again, I will continue to update you as I receive new information but remain available by phone or email if you have any questions. City Hall Building Management will also provide further direction for meeting room protocols in City Hall as we move closer to resuming in-person meetings. Commission secretaries should be working with their assigned Deputy City Attorneys and communicating with their commissions/boards to start thinking through meeting logistics, needed resources, timelines and legal questions so that they can be ready to move forward with inperson meetings when permitted.

The new body constitutes a broad array of experiences and expertise from local elected leadership, CBOs, and the private sector to support the City's priorities, policies, and funding needs of LGBTQI+ populations

**San Francisco, CA** — Mayor London N. Breed today appointed 25 members to the City's newly restructured LGBTQI+ Advisory Committee. The Committee, which is San Francisco's only LGBTQI+ focused legislative body, was revamped under the Mayor's leadership and includes representation from the Offices of Speaker Nancy Pelosi, California State Senator Scott Wiener, and District 8 Supervisor Rafael Mandelman.

The update to the Committee, announced during Pride Week, allows for greater representation from the public, private, and non-profit sectors, and aims to bolster and streamline citywide strategies, provide policy recommendations, and better engage the City through a unified leadership body.

"This is a historic milestone for our LGBTQ communities in San Francisco," said Mayor Breed. "The committee has a rich history, and today we are affirming its leadership by expanding its representation. Moving forward, elected officials, non-profit leaders, community members, and other partners will come together and communicate under one body."

"I am honored to have been selected to be part of the new LGBTQI+ Advisory Committee, because it's deeply important to have LGBTQ people in leadership positions to make decisions and advise on issues related to our community," said Senator Scott Wiener. "San Francisco has and will continue to lead on LGBTQ issues, and I commend our Mayor for her strong support for the LGBTQ community."

"For decades, the Advisory Committee had a direct impact on ground-breaking legislation impacting the City's diverse LGBTQ+ communities," said Supervisor Mandelman. "Now, we can look forward to this inspiring new membership to facilitate stronger conversations within City Hall and offer unique perspectives on the policies and issues affecting us today. I look forward to working with my fellow Committee members to advocate for our diverse communities."

Housed within the San Francisco Human Rights Commission, the LGBTQI+ Advisory Committee was established in 1975 to provide assistance and advice to the Commission regarding discrimination against LGBTQI+ communities, advocate for the civil rights of people with HIV/AIDS, and educate LGBTQI+ communities about public resources and direct services. Since then, the Committee was an integral part of LGBTQI+ advocacy and public policy. Over the years, Committee members and staff issued reports and incubated policy measures that led to legislation such as domestic partnership benefits, the formation of the LGBT Aging Policy Task Force, and more.

After a period of dormancy, Mayor Breed and the Human Rights Commission prioritized a revamp of the Advisory Committee to contemporize and better serve the needs of San Francisco communities today. Since 2018, the Commission hosted numerous outreach meetings and stakeholder engagement within the community to solicit feedback on the future direction of the Advisory Committee. This led to the formation of a new, 25-member body with the ability to include representation from elected officials, designated seats for CBOs and non-profits, and general seats from community members and leaders working to uplift LGBTQI+ communities regionally.

People of color make up 75% of the Committee's members, and has 50% Transgender and Nonbinary representation, making it one of the City's most diverse legislative bodies.

"Many of the City's challenges today disproportionately impact our most vulnerable populations, the most recent example seen during the COVID-19 pandemic. The Mayor and Human Rights Commission worked hard to ensure equitable COVID response and recovery that was informed in partnership with San Francisco's diverse BIPOC and LGBTQI+ communities. Equity, intersectionality, and LGBTQI+ justice was at the forefront of our community engagement process and was critical to our success," said Dr. Sheryl Davis, Director of the Human Rights Commission.

"It's such an honor to be a part of this new chapter for the Advisory Committee," said Joseph Sweiss, Vice Chair of the Human Rights Commission. "The more we learned about the history and legacy of the Advisory Committee, the more we were inspired to create a bold, new body that gives everyone a seat at the table. Through this new format, the Committee will enable the organizations and leaders already working within the community to better address the overlaps, gaps, and overall needs and come up with solutions together." The new Bayview facility houses the City's Emergency Medical Services Division, providing efficiencies to support improved emergency response times and ensure resiliency during natural disaster incidents

**San Francisco, CA** — Mayor London N. Breed today joined City officials and community leaders to celebrate the completion of the new San Francisco Fire Department Emergency Medical Services Station No. 49, which will serve as the home of the Fire Department's Emergency Medical Services Division and house the City's fleet of ambulances.

The new 58,451-square-foot facility, located at 2241 Jerrold Avenue in the Bayview, stands four stories tall and replaces the previous Emergency Medical Services headquarters, which was located in San Francisco Fire Department's logistics warehouse at 1415 Evans Avenue. The new headquarters has state-of-the-art technologies designed to meet the specialized needs of Emergency Medical Services staff and will allow first responders to better prepare their

ambulances for deployment when responding to calls for emergencies and health crises.

"The new Emergency Medical Services Station will help our first responders meet the demands of our growing city," said Mayor Breed. "This new facility will help our first responders do what they do best – get out there quickly to people in need. Whether it's responding to everyday emergency calls or handling the next big disaster, we need to be ready."

Each year, the San Francisco Fire Department's Emergency Medical Services Division responds to approximately 90,000 calls, which averages 250 calls on a given day. The division staff, which consists of 200-plus paramedics and Emergency Medical Technicians, responds to an extensive array of medical and traumatic injuries, including but not limited to vehicular accidents, large multi-casualty accidents, bicycle crashes, maritime injuries, heart attacks, drug overdoses and behavioral health emergencies.

"This new Fire Facility is a crucial investment for the future of emergency response in San Francisco," said San Francisco Fire Chief Jeanine Nicholson. "As the first facility solely dedicated to the Fire Department's Emergency Medical Services Division, our paramedics and EMTs will be better prepared for the job and able to more efficiently serve San Francisco residents when they need us the most."

The new facility, which was built from the ground up, is seismically safe and designed to withstand a major earthquake or other natural disaster. Its design achieved sustainable LEED Gold rating for new construction and will allow ambulances to provide optimal operations for first responders across the City. The building is equipped with parking for the City's ambulance fleet, storage for crucial ambulance supplies and restocking, Emergency Medical Services offices, conference and training rooms, locker rooms and communal space for first responders. There also is an on-site fueling station, an emergency 72-hour generator, solar panels and will feature entry gates with public art by local artist Michael Bartalos. Bartalos' *Serving the City* speaks to the history and visual vernacular of the Emergency Medical Services and the communities that it serves. The gates depict San Francisco's neighborhoods and landmarks and express the strength, courage and commitment of the ambulance personnel working within the new facility.

"Having a state-of-the-art Emergency Medical Service Station in District 10 has me overjoyed," said President of the Board of Supervisors Shamann Walton. "The ability to address emergencies swiftly is the difference between life and death, and I'm excited about having this facility in our own backyard. This major investment will save lives and improve our ability to rapidly respond to emergency calls."

"Whether in times of great disaster or for urgent medical calls, we need to ensure our EMTs and paramedics are well equipped to help," said San Francisco City Administrator Carmen Chu. "San Franciscans understand the importance of investing in our first response infrastructure including the new home of the Fire Department's Emergency Medical Services Division."

San Francisco Public Works managed the \$50.1 million project and hired MEI/MarJang Joint-Venture Architects for the design of the building. S.J. Amoroso Construction served as the general contractor for the project. From the start of construction in fall 2018, the project has provided 77 jobs, resulting in nearly 100,000 working hours.

"As with each of our construction management and design jobs, Public Works is proud to deliver another world-class project that will serve San Franciscans for generations to come," said Acting Public Works Director Alaric Degrafinried. "We take great pride in partnering with skilled contractors and other City agencies to provide capital infrastructure projects to serve the critical needs of our diverse communities."

The San Francisco Fire Department Emergency Medical Services Station No. 49 replacement project was funded by the 2016 Public Health and Safety Bond, which allocated \$350 million toward capital improvements for City facilities to meet the critical health and safety needs of San Francisco. San Francisco voters approved the bond with nearly 80 percent support.

To continue work to help meet of the critical needs of the City, San Francisco voters in November 2020 approved the Health and Recovery Bond. This \$487.5 million bond will fund essential City infrastructure and support San Franciscan's mental and physical health with new investments in parks, open spaces, behavioral health facilities and housing and shelter for vulnerable populations. The City and the San Francisco Giants are partnering to get as many San Franciscans vaccinated as possible, offering a free pair of tickets to a future Giants game starting this Friday, June 25 at several San Francisco neighborhood sites

**San Francisco, CA** — The Department of Public Health and COVID Command Center announced a partnership today with the San Francisco Giants to get as many residents vaccinated against COVID-19 as possible. Beginning this Friday, June 25, people who get vaccinated at one of San Francisco's designated vaccination sites will receive two complimentary tickets for a Giants game between July and September, first come, first served, while supplies last. The initiative is part of Major League Baseball's 'Vaccinate at the Plate' campaign; a national effort to increase national vaccination rates.

"San Francisco has led the nation in our effort to vaccinate our residents by making vaccines

available, accessible, and convenient. While we're proud to have been the first major city in the country to administer at least one dose to 80% of our eligible residents, we're not going to slow down our efforts to reach each and every San Franciscan," said Mayor London Breed. "I want to thank the Giants for partnering with us to provide yet another reason for everyone to step up to the plate and get vaccinated."

San Francisco's reopening and recovery is, in large part, due to the effectiveness, availability, and successful rollout of vaccines, which have dramatically driven down case rates, hospitalizations, and community spread. Currently, 81% of San Franciscans eligible for a COVID-19 vaccination have received at least one dose; the first major city in the nation to reach this milestone. As of June 20, 72% of San Francisco's eligible population are fully vaccinated and 81% of those 65 and over are fully vaccinated. However, disparities persist with the percentage of Black/African American and Latinx populations receiving at least one dose standing at 57% and 69%, respectively.

"Every eligible person who gets vaccinated is making San Francisco safer for themselves and everyone else," said Dr. Grant Colfax, Director of Public Health. "We thank the San Francisco Giants for joining the Public Health Department, our health providers and our community partners as we work to vaccinate all of our residents. Those who are eligible that still need to get vaccinated should do so as soon as possible."

"While it is so encouraging to see the impressive vaccination numbers in San Francisco, the Giants and Major League Baseball are committed to doing what we can to encourage all members of our community to get vaccinated," said Giants President and CEO Larry Baer. "We hope we can entice them with the opportunity to attend a game at Oracle Park and a return to more normal times while prioritizing their health."

Beginning June 25, 2021, anyone receiving their first dose vaccine in San Francisco can receive Free San Francisco Giants Vouchers, redeemable for two tickets to selected games between July and September 2021, first come, first served, while supplies last, courtesy of the San Francisco Giants and Major League Baseball. There are no residency requirements to be eligible for tickets. Redemption information is provided on the voucher.

Legislation will allow the Department of Human Resources to collect voluntary and anonymous sexual orientation demographics from City employees and applicants to ensure that hiring reflects the diversity of San Francisco

**San Francisco, CA** — Mayor London Breed and Supervisor Rafael Mandelman today introduced new legislation to the San Francisco Board of Supervisors that repeals 12E of the Administrative Code, which prohibits the City from inquiring into "sexual orientation, practices, or habits" of City employees.

The City and County of San Francisco is the largest employer in San Francisco, with approximately 37,000 employees who reflect the vibrant and diverse populations of the region. Yet, while the City and County collects certain anonymous demographic information from applicants for City employment, little is known about applicants or the City workforce regarding LGBTQ identities. The amendment to the code will allow the Department of Human Resources to collect voluntary and anonymous sexual orientation demographics from City employees and applicants.

San Francisco is a leader in LGBTQ rights and has a rich history of LGBTQ and HIV

advocacy; art and culture; and groundbreaking legislation and social programming. As a result, LGBTQ communities worldwide look to San Francisco as a model to follow – a city that understands how crucial it is for diverse communities to be seen, counted, respected, and celebrated.

"As we celebrate Pride month in San Francisco, it's important that we step back and ensure that we're doing everything we can to live up to our values, and that includes hiring and retaining a diverse workforce that reflects our community," said Mayor Breed. "This section of our Administrative Code was originally designed in a different era to protect LGBTQ employees from discrimination and harassment, but it has now outlived its purpose. With this change, we'll be able to look at the data and make any changes needed in our hiring practices. I want to thank Supervisor Mandelman for partnering with us on this important legislation."

This new policy builds off Mayor Breed's <u>Executive Directive</u> to assure City services are LGBTQ affirming by requiring departments to provide gender inclusive options and selfidentifiers on all City forms and applications. The directive also expanded required trans inclusion training to all City employees working with the public. Also, Mayor Breed has prioritized appointing LGBTQ community leaders to City boards and commissions; since her inauguration in 2018, she has appointed or reappointed over 48 LGBTQ commissioners, making up 15% of all appointments.

"I am grateful for Mayor London Breed's leadership and partnership on this new legislation that will help San Francisco more effectively identify, measure, and address the needs of our LGBTQ City employees and applicants," said Supervisor Rafael Mandelman. "Furthermore, the legislation will allow for the Department of Human Resources to better track our Citywide equity goals, address gaps, and identify strategies to recruit LGBTQ employees interested in public service."

"This important policy change will give the City invaluable data on our LGBTQ workforce and help identify potential barriers to City employment and advancement," said Carol Isen, DHR Human Resources Director. "We look forward to implementing this change and expanding additional equity efforts that support pathways to City employment for the LGBTQ community."

"This legislation is critical to support San Francisco's efforts to advance LGBTQ rights and inclusion in the workplace," said Clair Farley, Executive Director of the Office of Transgender Initiatives. "Our team is proud to have worked with City to expand critical data collection to include our LGBTQ community and employees while assuring we have inclusive policies and and training programs to assure a safe and affirming workplace – despite the challenges of the pandemic we were able to train over 2,000 City employees through our LGBTQ Inclusion Trainings."

#### **Additional Background on Chapter 12E**

With certain narrow exceptions, Chapter 12E (City Employee's Sexual Privacy Ordinance) of the Administrative Code prohibits the City from inquiring into "sexual orientation, practices, or habits" of City employees. In practice, this prohibited collection of sexual orientation and accurate gender identity information from City employees.

When enacted in 1985, Chapter 12E was necessary to protect LGBTQ City employees and applicants from potential discrimination at the height of the HIV/AIDS epidemic. At that time,

the larger population often assumed that any member of the LGBTQ community might be living with HIV/AIDS and carried a tremendous stigma attached to it. This perception has shifted over time, given that discrimination and harassment based on HIV status, sexual orientation, and gender identity have since become prohibited under federal, state, and local law, as well as City policy.

The City remains committed to upholding protections for its LGBTQ applicants and employees, and to maintaining the privacy of all its applicants and employees by collecting data about sexual orientation and gender identity on a voluntary and anonymous basis. # MAYOR LONDON BREED ANNOUNCES OPENING OF NEW PERMANENT SUPPORTIVE HOUSING

San Francisco and United States Department of Housing and Urban Development (HUD) partner to fund new permanent supportive housing at the Post Hotel, as part of the Mayor's historic Homelessness Recovery Plan, the largest expansion of permanent supportive housing in 20 years

**San Francisco, CA** — Mayor London N. Breed today announced the opening of the Post Hotel, creating 89 units of housing for adults moving out of homelessness. In partnership with HUD, the City has provided funding to Episcopal Community Services (ECS) to lease and operate the Post Hotel as Permanent Supportive Housing (PSH), which provides long-term affordable housing with on-site social services to people exiting chronic homelessness. Currently, more than 10,000 people live in the City's PSH.

These new units are part of Mayor Breed's historic Homelessness Recovery Plan, announced in July 2020, to support investments in housing and shelter that will help the City create more resources for homeless residents and create 10,000 placements to support homeless residents.

As part of that plan, the City has implemented or is implementing the following:

- 1,500 new adult PSH units, including two new Homekey projects and new flex pool subsidies,
- 3,000 additional adult PSH placements,

- 225 Rapid Rehousing & medium-term housing subsidies for adults & transitional age youth,
- Launching new Problem Solving resources to support one-time and short-term financial assistance to address immediate needs and help individuals quickly exit from homelessness
- Opening of two new Navigation Centers at 1925 Evans and 888 Post with a post-COVID capacity of 275 beds,
- Re-opening1,000 shelter beds (timing dependent on public health guidelines).

In addition to these investments, the Mayor recently announced that the City will leverage over \$1 billion to advance and significantly expand the work started through the Mayor's Homelessness Recovery Plan over the next two years, including adding another 4,000 housing placements.

"We know we need more housing if we are going to make a difference addressing homelessness," said Mayor Breed. "We moved thousands of unsheltered people into emergency housing throughout the pandemic, and we must build on that progress to expand our homelessness response. Permanent supportive housing at places like the Post Hotel are essential to providing long-term solutions to our City's most vulnerable communities."

"The U.S. Department of Housing and Urban Development is proud to partner with the City and County of San Francisco by providing approximately \$2 million in operating subsidy for the Post Hotel," said HUD's Deputy Regional Administrator Wayne Sauseda. "We applaud Mayor London Breed and San Francisco's Department of Homelessness and Supportive Housing for continuing to invest in permanent housing solutions to prevent and end homelessness."

"This partnership and investment with HUD demonstrate that permanent supportive housing is a critical solution to ending chronic homelessness," said Shireen McSpadden, Director of the Department of Homelessness and Supportive Housing. "I'm excited that the Post Hotel adds new units to the city's Homelessness Response System, while providing stabilization and a new and hopeful pathway for people exiting homelessness."

The Post Hotel was previously an 89-unit Single Room Occupancy building. Eligibility for PSH units is determined by the City's Coordinated Entry prioritization process, which is founded on equity and removes barriers to housing. The Post Hotel is funded by a \$1,968,750 grant per year in HUD Continuum of Care (CoC) dollars. The City will also utilize \$300,837 in local funding for start-up costs and ongoing operations.

"Permanent Supportive Housing remains a proven solution to resolving chronic homelessness for the most vulnerable neighbors experiencing homelessness," said Episcopal Community Services Executive Director Beth Stokes. "The Post Hotel represents yet another example of Mayor Breed's commitment to addressing our homelessness crisis through direct investments in housing with services and we are grateful for her continued leadership on this critical issue."

Every night, the City provides shelter and housing to over 14,000 homeless and formerly homeless people across the community. In September and October 2020, the City applied for, and was awarded a combined \$78 million dollars from the State to purchase two hotel properties through Project Homekey. This funding allowed the City to purchase the Granada Hotel and the Hotel Diva, adding approximately 362 units of Permanent Supportive Housing, as part of Mayor Breed's Homelessness Recovery Plan.

Art installation honoring Black lives arrives for Juneteenth, will stay in Music Concourse for two years

**San Francisco, CA** — In commemoration of San Francisco's Juneteenth holiday, Mayor London N. Breed today unveiled Monumental Reckoning, a two-year art installation in Golden Gate Park honoring Black history and lives.

The piece, by Bay Area artist Dana King, consists of 350 black sculptural figures standing 4 feet high in the park's Music Concourse. Representing the 350 souls kidnapped from Africa and forced onto the slave ship San Juan Bautista in 1619, they surround the empty pedestal where a statue of Francis Scott Key once stood. Protestors toppled the statue on Juneteenth of 2020. Key, who wrote the lyrics to the Star-Spangled Banner, was a slave owner and abolition opponent.

A procession led by Black women preceded the art opening as members of the Glide Ensemble sang "Lift Every Voice and Sing." Civil rights champion James Weldon Johnson's hymn is often referred to as the Black National Anthem.

The ceremony comes one day after Joe Biden signed a resolution establishing June 19 as Juneteenth National Independence Day, a U.S. holiday commemorating the end of slavery in

the United States.

"Juneteenth is a recognition of our culture and accomplishments, but it's also a solemn reminder of the bonds of slavery and the struggle for equality that continues today," said Mayor Breed. "Monumental Reckoning honors that painful history while celebrating our resilience and our future. It is civic art that allows the public to think, feel and explore in a place that belongs to all of us."

"I want Monumental Reckoning to be a space where people come to commune with the ancestors—to laugh, cry, sing, dance and recite poetry. More importantly, I pray that people will speak to others who don't look like them, sharing stories that lead to deeper understanding and connection, making choices that lead us all to freedom," King said.

"Despite what outdated history books have stated, the United States of America actually began in 1619 when a group of enslaved Africans arrived in Jamestown, Virginia. That was the beginning of building a white supremacist nation," stated Director of Cultural Affairs Ralph Remington. "Since that time all people of African ancestry have struggled to breathe free in a country that wasn't designed for them, but instead used them as mules to build its immense wealth. Stolen people on stolen lands. I am gobsmacked that amidst all of the pain suffered by Black people over centuries, that this country still practices pernicious and malicious indifference regarding our collective struggle. Dana King's 350 sculptures confront us with references to the individual souls—our ancestors—who were stolen from Africa 400 years ago. It is a clarion call."

"Black history is central to understanding American history, yet for far too long it was diminished or inaccurately portrayed. Hosting this extraordinary art installation in Golden Gate Park amplifies the African American experience, allowing millions of visitors from across the world to reflect on the legacy of slavery, the incredible contributions of Black Americans, and the power of art in our public spaces," said San Francisco Recreation and Park Department General Manager Phil Ginsburg.

Monumental Reckoning will run until June 20, 2023. A proposed companion piece by Illuminate the Arts, the words "Lift Every Voice" shining from atop the Spreckels Temple of Music, will go before the Historic Preservation Commission for approval July 21.

# \*\*\* STATEMENT \*\*\* MAYOR LONDON BREED ON JUNETEENTH

"Today San Franciscans come together to celebrate Juneteenth, the day commemorating the end of slavery in the United States. For the first time, this monumental day has been recognized as a national holiday that will forever commemorate the lives and struggle of those who have come before us. Growing up as a Black woman in the Fillmore, Juneteenth has always been a special day for me. I remember cowboys riding their horses through crowds of performers, both young and old, re-enacting the emancipation of our ancestors. Celebrating this day with my community always made me feel part of something larger than myself.

Juneteenth is not just a reminder of our history of being enslaved and our prolonged struggle for equality; it's a celebration of the contributions Black San Franciscans have made to the City we all love. It's about our grandparents, who migrated from the Jim Crow South, worked tirelessly, and helped build our City's economy. It's about the legacy of jazz in the Fillmore that paved the way for today's artists and musicians. And it's about San Francisco's fighting history to ensure racial and economic justice for all Americans.

In May of last year the systemic injustice emanating from hundreds of years of racism and mistreatment of Black Americans was put into plain view when we witnessed the murder of George Floyd at the hands of the police. While we're now a year removed from the mass protests that erupted across the country and the world, I have not forgotten about the challenges that our Black community continues to face.

We have taken bold steps to fight racial injustices facing our City's declining Black working

class. Investments like the Dream Keeper Initiative, which will provide an annual investment of \$60 million to help support Black residents, communities, and businesses. I understand that funding alone will not heal generational wounds of disinvestment and economic inequities. But I can assure you that I will continue to work every day to make San Francisco a safe place for every individual, regardless of their skin color.

As we celebrate Juneteenth this year, let us remember those we have lost to injustices and inequality. In a city that prides itself on embracing diversity, promoting inclusion, and being a beacon of hope, we must do better living up to these standards. For too long, Black lives in America have been overlooked. We must demand justice and work to change the systems that have kept so many of our friends and family members pinned down, and we must support and empower one another as we build a just and equitable country that we can be proud to call home."

Ortega, Richmond/Sen. Milton Marks Jr. and Visitacion Valley branch libraries reopen for in-person service

**San Francisco, CA** — Mayor London N. Breed and City Librarian Michael Lambert today announced the San Francisco Public Library (SFPL) will reopen additional neighborhood branches for limited indoor and front door pick-up service starting today, June 21. More branches are slated to open throughout the summer as staffing permits and as San Francisco continues to make progress on its recovery. Since last year, many SFPL employees have been deployed as Disaster Service Workers supporting the City's COVID-19 response in a variety of essential roles and 10 neighborhood branches served as community learning hubs to support the City's most vulnerable youth and families with distance learning.

On May 3, SFPL reopened the Main Library and successfully launched its "Browse and Bounce" program, which is also available at the Chinatown/Him Mark Lai Branch Library and Mission Bay Branch Library. The express in-person service welcomes Library cardholders back inside for 60-minute sessions to browse library books, music, movies and more, pick up holds and check out materials, ask reference and information questions from Library staff and schedule a 60-minute computer session. Patrons can also access photocopiers, printers, fax and scanners.

San Francisco will open four new Browse and Bounce locations this week: Ortega, Richmond/Sen. Milton Marks Jr. and Visitacion Valley Branches open June 21, and the Excelsior Branch opens June 22.

"Our public library stepped up in more ways than one to help this city during this unprecedented time of need, but now it's time to start getting back to regular business," said Mayor Breed. "It's not going to happen overnight, but the fact that we are bringing more neighborhood libraries online for service is a great sign of progress as we continue down the path of recovery. I encourage all residents to rediscover all of the incredible resources the library offers."

The Browse and Bounce service operates alongside SFPL To-Go, the Library's popular frontdoor holds pick-up service, which is also expanding this week with six new locations: Bernal Heights, Golden Gate Valley, Ingleside, North Beach, Sunset and Western Addition. SFPL To-Go is now available at 18 libraries and four bookmobile locations throughout the City. In July, the Library will aim to open the Bayview, Bernal Heights, Eureka Valley, Glen Park, Oceanview and Western Addition branches for Browse and Bounce, and the Presidio, Parkside and Noe Valley branches will launch SFPL To-Go. The Library is aiming to have all library locations reopened for in-person services before the fall school year begins.

Since March 2020, hundreds of Library staff have played a critical role in the City's COVID-19 response, serving as Disaster Services Workers in various positions. Library staff have supported the City's emergency response working at food pantries, COVID-19 testing sites, Community Hubs for students, and Shelter-in-Place hotels. Library staff continue to serve as contact tracers and case investigators working to slow the spread of the virus in the community and part of the COVID Command Center's efforts to conduct outreach work, translations, copywriting, and communications. Despite the fact that some staff are returning to their pre-pandemic roles with the gradual demobilization of the City's COVID-19 response, staffing levels remain too low to fully reopen all branches due to a large number of vacancies. At present, the Library's workforce is down by nearly a quarter.

"We are doing the best with the personnel we have to fully reopen all of our neighborhood libraries as expeditiously as possible," says City Librarian Michael Lambert. "In the meantime, we can't wait to welcome our beloved patrons back through our doors for Browse and Bounce and provide access to collections at our SFPL To-Go locations."

As part of the City's Summer Together initiative, SFPL is giving away 10 books to all San Francisco Unified School District students. Students and caregivers can pick up their book bundles at any Browse and Bounce or SFPL To-Go location. Additionally, the Library's Summer Stride program is in full swing with programs for all ages. Individuals who complete 20 hours of Library activity (reading, attending an event and visiting a library all count) can earn prizes and a coveted 2021 Summer Stride tote bag with original artwork by Bay Area artist Kaylani Juanita. ### Safety Measures

Capacity and services will be limited at all in-person San Francisco Public Libraries. Patrons will be required to abide by all safety requirements and library rules, including social distancing and wearing masks. As the City addresses changes in the safety requirements for City employees, the City and County of San Francisco continues to require that anyone entering City owned or leased facilities wear face coverings regardless of vaccination status. The City will revisit this requirement later this month and provide the public with additional guidance.

To ensure the safety of library users and staff, SFPL has developed a number of safety protocols and enhancements including:

# CITY BREAKS GROUND ON INDIA BASIN SHORELINE PARK

'Once in a generation' project, which is already supported by local and philanthropic funding, to receive \$25 million from state in most recent budget

**San Francisco, CA** — Mayor London N. Breed today joined with community members, environmental advocates, and public officials to kick off the restoration of India Basin shoreline. The cleanup marks the first phase in a once-in-a-generation environmental justice project that will deliver a \$140 million shoreline park to the heart of the Bayview.

Governor Gavin Newsom's proposed budget, approved by state legislators this week, earmarks \$25 million for the project. The budget must be finalized by June 30. This state funding bolsters the \$29 million earmarked for the project through San Francisco's 2020 Health and Recovery Bond and a \$25 million gift from the Pritzker Family Fund in 2019, the single largest private gift ever for the creation of public parkland in San Francisco.

"Funding the India Basin project means investing in the health and well-being of Bayview residents. It would contribute to achieving a clean, healthy shoreline and access to all of its benefits for generations to come," Governor Newsom said.

"San Francisco going to come back from this pandemic stronger than ever. This significant investment from the state helps us ensure that every neighborhood benefits from our city's economic recovery and commitment to environmental justice," said Mayor Breed. "The India Basin project is creating jobs in the Bayview, while also creating an extraordinary shoreline park that reflects the neighborhood's history, arts and culture."

Bayview-based Rubecon Builders is leading the remediation, which will occur on land as well as within the shallow waters immediately north of the site at 900 Innes Avenue. Workers will remove debris and dilapidated structures, excavate soil, and remove decades of industrial pollution leftover from the site's decades of building and repairing ships. The process will be overseen by the San Francisco Bay Regional Water Quality Control Board.

The cleanup efforts will restore a critical tidal marsh and wildlife habitat in the southeast corridor of San Francisco. This restoration is the first step in a plan to revitalize and unite a series of existing waterfront open spaces into a seamless design offering 1.7 miles of contiguous public open space. It will provide unrivaled recreational access for 2,500 units of public and affordable housing, either existing or planned, within one mile of the future park.

In addition to the \$25 million earmarked in the current state budget, additional state funding includes a \$8.5 million grant provided through Proposition 68, a \$4 billion bond passed by California voters in June 2018 to ensure parks are safe, properly managed and accessible to everyone, as well as \$4 million in state budget funds secured with the help of Assemblymember Phil Ting.

Measure AA, a clean water and habitat restoration measure placed on the ballot by the Bay Restoration Authority and passed by voters in the nine Bay Area counties, provides nearly \$5 million in funding.

The India Basin waterfront project is a partnership with the Bayview Hunters Point community, the A. Philip Randolph Institute, the Trust for Public Land, and the San Francisco Parks Alliance. The project will combine the abandoned industrial site at 900 Innes Avenue, which the City acquired in 2014, with two existing parks that border it: India Basin Shoreline Park and India Basin Open Space, both of which would undergo significant improvements as part of the broader vision.

Once complete, the new park will include gathering docks for people to socialize along the restored shoreline; an accessible walkway and stairs to connect Bayview-Hunters Point with the expanded park, gardens and natural habitats; a public plaza for fitness classes, performances, and farmers markets; a lighted bicycle and pedestrian path that will close a gap in the Bay Trail, linking the Embarcadero to Candlestick Point; and an ecological education area where visitors can observe tidal mudflat habitats and native birds through small paths, decks and viewing platforms.

"I'm excited to see all of the work to make today possible come to fruition. We have been fighting for more open space and beautiful parks in the district for years. The community input and focus on eliminating blight is environmental justice in action. So proud of everyone for coming together to make this a reality. The park is another major asset for our neighborhood and a testament to the continued commitment to providing our residents with beautiful parks. This is a major milestone," said Board of Supervisors President Shamann Walton, representing District 10.

"Justice for underserved communities means equal access to nature and its abundant mental and physical health benefits," said San Francisco Recreation and Park Department General Manager Phil Ginsburg. "This project is more than just providing green space or even revitalizing ecosystems. Every aspect of this future world class park has been intentionally and thoughtfully designed to meet the needs the community has identified."

A key goal of the India Basin project is to serve as an anchor for equitable and inclusive economic growth. The project relies on First Source Hiring, a program administered by the Office of Economic and Workforce Development that gives economically disadvantaged individuals in the program the first opportunity to apply for entry-level jobs in San Francisco.

Bayview Hunters Point residents identified workforce and business development as a major component of a community-drafted document outlining the process by which this project can serve as a model of equitable development. This Equitable Development Plan details six areas of focus: Arts, Culture & Identity; Workforce and Business Development; Connectivity, Transit, Access & Safety; Healthy Communities & Ecology; and Youth Opportunities.

"Our intention is for the community to take ownership of this space, which has always been closed off to the public," said Jacqueline Flin, Executive Director of the A. Philip Randolph Institute, which works for civil rights and fair labor practices and is among the project's partners. "We want the community to be involved in every step of the process. This includes developing programs to train residents of Bayview Hunters Point and employ them on this project. From construction to concessions to park maintenance and beyond we are committed to building equity from within the community. We are working with city, local businesses and nonprofit partners to create a pipeline for folks to establish careers and truly feel like this park is theirs to enjoy and take part in."

"Communities not only deserve quality parks and open space, they also need investments like jobs and opportunities for local small businesses to benefit from park development. This is why The Trust for Public Land sees the India Basin Shoreline Park project as a national model of how cities should design and build parks centered on equity," said Guillermo Rodriguez, California State Director with The Trust for Public Land. "When you listen to the community, you can not only deliver a great park but use the opportunity to hire locally, address transit and housing issues, and develop plans to make sure the residents living here now benefit for years to come because of this park project."

# SAN FRANCISCO PUBLIC UTILITIES COMMISSION OFFICIALLY RECOMMENDS DENNIS HERRERA TO LEAD DEPARTMENT

Herrera, nominated by Mayor Breed, would serve as the next General Manager for the San Francisco Public Utilities Commission

**San Francisco, CA** — Mayor London N. Breed and San Francisco Public Utilities Commission (SFPUC) President Sophie Maxwell announced today that SFPUC has officially recommended City Attorney Dennis Herrera to serve as the agency's next General Manager. Herrera was elected as City Attorney of San Francisco in 2001, and will bring decades of experience serving City residents and advancing environmental policies through his nationally-recognized office.

Mayor Breed nominated Dennis Herrera to the SFPUC in April 2021, and since then the SFPUC has been undergoing review process led by the 5 member oversight commission. The Commission's nomination process, which consisted of meetings with both internal and external stakeholders, as well as a survey to all active employees, identified qualities and challenges for the new General Manager. Following initial discussions and collaboration with employees, the five-member commission that oversees the SFPUC interviewed City Attorney Herrera – covering a wide range of topics including: challenges facing the SFPUC, management style, public integrity, the environment, short- and long-term goals, collaboration, equity, diversity and inclusion (EDI), and communication.

"Dennis Herrera has been a champion of this City across a wide range of issues from civil rights to protecting our environment, and I am proud to have nominated him for this critical leadership position," said Mayor Breed. "I appreciate the thorough work that President Sophie Maxwell and the Commission members put into this process, and I'm glad we are moving onto the next step. Dennis is the right leader for the hard-working employees of the SFPUC and this City.

"The Commission looks forward to working with Dennis Herrera and continuing on our mission of making this agency an outstanding utility of the future," said SFPUC President Sophie Maxwell."

Throughout the nomination process, the five-member commission was impressed by Herrera's understanding of issues facing SFPUC, his 20 years of ground-breaking leadership on issues of importance to San Franciscans, 20 years of department management, commitment to equity, diversity and inclusion, commitment to staff support and collaboration, and enthusiasm and energy for the road ahead. Mayor Breed has accepted the recommendation from the SFPUC. Next steps are for the Commission to come to contract terms with Herrera before the appointment becomes official.

The SFPUC provides retail drinking water and wastewater services to the City of San Francisco, wholesale water to three Bay Area counties, green hydroelectric and solar power to Hetch Hetchy electricity customers, and power to the residents and businesses of San Francisco through the CleanPowerSF program.

"San Francisco's public utility deserves innovative and decisive leadership," Herrera said. "I am ready to stand up for ratepayers and meet the challenge of responding to climate change. I look forward to leading San Francisco's public utility in partnership with the Commission and getting to know the hard-working employees who serve the department. I am committed to ensuring that all San Franciscans have clean and reliable water, sustainable and affordable public power and a public utility that they can be proud of. My approach to government has been, and will continue to be, with a focus on diversity and equity. I want to thank Mayor Breed and the Commission for their support. I am honored to have this unique opportunity to face the challenges of the future as the General Manager of the San Francisco Public Utilities Commission."

"It has been a privilege to serve San Francisco as the City Attorney for nearly 20 years," Herrera said. "We advanced equality for all, stood up for civil rights, supported affordable housing at every turn, gave our children better opportunities to grow and thrive, and took innovative steps to protect the environment. We met challenges head on and stood up for what was right."

For nearly two decades, Herrera has been at the forefront of pivotal water, power and sewer issues. He worked to save state ratepayers \$1 billion during PG&E's first bankruptcy in the early 2000s and has been a leading advocate for San Francisco to adopt full public power for years.

In 2009, he reached a key legal agreement with Mirant to permanently close the Potrero Power Plant, San Francisco's last fossil fuel power plant, and secured \$1 million to help address pediatric asthma in nearby communities.

In 2018, Herrera defeated an attempt to drain Hetch Hetchy Reservoir, the crown jewel of the SFPUC system, which provides emissions-free hydroelectric power and clean drinking water to 2.7 million Bay Area residents. He is also leading efforts before the Federal Energy Regulatory Commission and the courts to fight PG&E's predatory tactics to grow its corporate monopoly by illegally overcharging public projects like schools, homeless shelters and affordable housing to connect to the energy grid.

Herrera is also currently suing the top five investor-owned fossil fuel companies in the world. The lawsuit, filed in 2017, seeks billions of dollars for infrastructure to protect San Francisco against sea-level rise caused by their products, including large portions of the SFPUC's combined sewer and stormwater system.

Herrera was first elected as City Attorney in December 2001, and went on to build what *The American Lawyer* magazine hailed as "one of the most aggressive and talented city law departments in the nation."

Herrera's office was involved in every phase of the legal war to achieve marriage equality, from early 2004 to the U.S. Supreme Court's landmark rulings in June 2013. Herrera was also the first to challenge former President Trump's attempts to deny federal funding to sanctuary cities. He repeatedly defeated the Trump administration in different cases as it sought to punish sanctuary cities, deny basic benefits like food stamps to legal immigrants, and discriminate in health care against women, the LGBTQ community and other vulnerable groups. He brought groundbreaking consumer protection cases against payday lenders, credit card arbitrators and others. He also brought pioneering legal cases to protect youth, including blocking an attempt to strip City College of San Francisco of its accreditation and getting e-cigarettes off San Francisco store shelves until they received required FDA approval.
