A. GENERAL PUBLIC COMMENT

SPEAKERS: Katherine Howard - San Franciscans for Urban Nature. At the March 3rd, 2021 meeting of the Historic Preservation Commission (HPC), a Request for a Certificate of Appropriateness to extend the operation of a temporary observation wheel installed in the Music Concourse was considered. The Recreation and Park Department offered proposals to mitigate the noise and fumes from the diesel generator, along with other measures to mitigate the impact of the Wheel. The noise and fumes from the diesel generator are still continuing and not all mitigations have been put in place. In addition, loud music has been added. You should have received our letter with more details and photos illustrating these issues. We request that the Historic Preservation Commission hold the Recreation and Park Department to the commitments that they have made.

B. DEPARTMENT MATTERS

1. Department Announcements

Rich Sucre, Deputy Director of Current Planning:

Good afternoon, Commissioners. Just wanted to provide you an update on some items that went before the Board of Supervisors. The Eagle passed its second reading at the Board of Supervisors yesterday. And so it is on its way to the mayor who will sign it into and becoming an ordinance so that it would be an official city landmark, which is wonderful. Also, at the Land Use meeting this past Monday, the board did not have any landmark items that were under review at this time. But we have a couple of items that are kind of lining up. Just to address some correspondence that you have received recently, the Department did--is researching the compliance for the Conditions of Approval regarding the ferris wheel project. So, we are currently aware of it and are on top of it. And so, we will provide you an update at a future meeting and we are in correspondence with the Rec and Park department. So, let me know if you have any questions or if there is anything else that you would like us to follow up on. Thank you.

2. President's Report and Announcements

President Matsuda:

Thank you, Rich, Mr. Sucre for giving us the update about that because I was going to mention it because of Ms. Howard's public comment and the email that we received from the San Francisco for Urban Nature. We also received another email today from Georgia Schuttish about the map Noe Valley and had mentioned, I guess that Planning staff person by the name of Mr. Webster, and I really couldn't understand what her specific request was but I was hoping that I could follow up or someone from the Planning Department staff about that. It is about today's agenda item. And then, Mr. John Templeton was planning to make public comment so I'm not sure what happened but he did contact me and he contacted me after he made a presentation to the Planning Department staff about seeing how we can revisit the African American historic context statement. So, I wanted to share that with the Commission and to see if we can--or if I can convene a meeting with Mr. Templeton and whoever that current staff person is in charge of this particular historic context statement to see how we can review that and push it along. So, Jonas, if you can put me in touch with whoever that, I'm not sure who has been assigned to that, but that would be great.

And just finally, today's agenda item was specifically created for us to spend a great deal of time on the housing element and particularly the mitigation alternatives. Mitigation measures because even though this is not specifically to create an ordinance, definitely the information and I think the framework that will be decided on will have a huge impact on any future ordinances that come before the board and the City. And I am hoping that all of us can spend some time to really consider what staff has provided for us. And staff has provided a really good overview but I think we could really really use the comments and the suggestions from the Commissioners. You know, this is going to set policy for the next 30 years. I mean, so we really want to take some time and really discuss things as thoroughly as possible. This won't be our last time, but I think that we should attempt to make a really good in road to what has been presented and make sure that we continue to follow up and have future meetings specifically on this subject. Thank you.

Rich Sucre, Deputy Director of Current Planning:

Hi Commissioner Matsuda. Yeah, we are happy to address all of your concerns so if on the Noe Valley matter you want to forward me the correspondence, I am happy to connect Ms. Schuttish with the right staff people. And then similarly on the African American context statement, as I understand, I think the biggest update on our end is the need for community outreach on that document. So, we are happy to convene a meeting and kind of figure out and put a timeline together for next steps so that way we can kind of bring it forward to this Commission for adoption. So, happy to facilitate in any way.
