<u>5 THIRD STREET</u> – southeast corner of Market and 3rd Streets; Lot 057 in Assessor's Block 3707 (District 6)—Request for a **Major Permit to Alter** to alter the two existing buildings on the lot (5 3rd Street and 17-29 3rd Street) to accommodate a change in primary use from offices to a hotel. This project was previously approved through Motion No. M-0372 at an HPC hearing on March 20, 2019. The project has undergone no changes since that time and is returning to the HPC solely to seek an extension of the expiration date of the original Motion. The subject property is listed as a Category I (Significant) building within the New Montgomery-Mission-2nd Street Conservation District and is located within a C-3-O (Downtown-Office) Zoning District and 120-X Height and Bulk District. <u>888 TENNESSEE STREET</u> – northwest corner of Tennessee and 20th Streets; Lot 001 in Assessor's Block 4060 (District 10) – Request for a **Certificate of Appropriateness** for the addition of a loading dock enclosure and trash enclosure (totaling 376 square feet), and façade alterations to an existing two-story industrial building. The work is limited to the west façade. The subject property is a non-contributing building in the Dogpatch Historic District, and is located within the UMU (Urban Mixed Use) Zoning District and 45-X Height and Bulk District. 2261 FILLMORE STREET (CLAY THEATRE) — west side between Clay and Sacramento streets; Lot 002 in Assessor's Parcel Block No. 0630 (District 2). Consideration to Recommend to the Board of Supervisors Landmark Designation of Clay Theatre (2261 Fillmore Street) as an individual Article 10 Landmark pursuant to Section 1004.2 of the Planning Code. Clay Theatre was initiated for designation by Supervisor Stefani on June 15, 2021 and adopted by the Board of Supervisors on July 27, 2021 (See BOS File No. 210726). Clay Theatre, constructed in 1913 as a nickelodeon movie theater, also known as the Regent, The Clay-International, and The Clay, is historically significant as one of the oldest single screen nickelodeon movie houses in San Francisco and for its association with the pioneering period of moving picture theaters and the development of film industry in San Francisco during the early 20th century. The Clay Theatre, an increasingly rare single-screen movie theatre building type in San Francisco, is also significant as an important destination for foreign and independent films throughout the 20th century. The subject property is in the Upper Fillmore NCD (Neighborhood Commercial District) Zoning District and 40-X Height and Bulk District.
