## **Extension Request for Temporary Installation**

Given the COVID-19 impact on the Wheel, Rec Park is proposing to extend the term of the Permit by <u>four</u> years for the following reasons for the temporary installation of the wheel:

- Fulfill Original Expectations
- Support the City's Economic Recovery

# Why? Economic Recovery


GGP has historically been **an engine of economic recovery** for the City:

- The 1894 Mid-Winter Fair that created the Music Concourse was put on in part to stimulate the California economy in a time of depression.
- In the 1930s and '40s, WPA construction projects in the park helped pull the city out of the Great Depression:



## Wheel Operations

#### Days Open

Originally scheduled to open on April 4, 2020

- Wheel opened October 21 with limited capacity
- Wheel closed on November 29 due to health surge

#### Access for All - Community Benefits

- **Operator to provide 500 tickets/month** to benefit underserved communities in San Francisco
- In November, we distributed tickets to non-profits operating Community Hubs, supporting distance learning for the City's most at-risk youth
- Only a few could be used before the shut down
- o 500 tickets will continue for a total of 25,000










**39** days in operation at **25%** capacity


**83** days minimum of closure since purple tier & Bay Area Regional Stay At Home Order

## Wheel COVID Safety Plan



Riders and all employees must wear masks



Must practice social distancing



Gondolas are private; doors are automatic.



Gondolas are sanitized between rides.



100% air exchange; fresh air vents open during ride



Tickets must be purchased in advance to avoid crowds. Tickets by the hour. Limited to 25% capacity





Hand washing station and hand sanitizer available



Riders must be in same household






#### **Responding to HPC Concerns - Lighting**

In response to HPC Conditions of Approval, RPD gathered additional feedback and implemented the following changes:

- White lights on the wheel spokes and perimeter were turned off, and only minimal safety lighting is turned on after 10pm.
- The light show no longer has white lights in the last hour of programming.

### **Responding to HPC Concerns - Generator**

In December, we heard concerns from HPC regarding impact of generator:

- **Immediately** operator has determined how to power down the generator safely at night by reprograming the computer system. A battery will be used for safety lighting.
- Short Term
  - Actively searching to identify options to buffer noise and find a replacement generator
  - Improve aesthetic appearance of fencing around generator and wheel
- Long-term initiated conversations with PG&E and PUC to provide additional power to the Concourse, not just for the wheel but for our neighboring institutions.
  - Goal that upgraded power will be one of the lasting legacies of the wheel
  - The 4-year term allows RPD the time and commitment to invest in infrastructure needed to bring additional power to the concourse

## **Extension Request for Temporary Installation**

Given the negative COVID-19 impact on the Wheel's operations, SFRPD is proposing to extend the Permit:

#### **Fulfill Original Expectations of Operations**

With the future availability of operational days for the wheel and future capacity limits unknown, this permit modification will both:

- Accommodate the anticipated riders from the original permit
- Provide for an increase in ridership to help offset the financial hardship suffered by the Operator.

The Operator has had to incur significant costs:

- To secure and maintain the wheel while it was closed
- To follow COVID safety requirements with extra staffing and protocols when it re-opened
- As well as losses due to the closure after 39 operational days at 25% capacity

Provide Fun to San Franciscans:

- Bring kids who may have never visited GGP to have an exciting opportunity to enjoy the park
- Overwhelming support from San Franciscans



# **Extension Request**



Given the negative COVID-19 impact on the Wheel's operations, SFRPD is proposing to extend the Permit:

#### Support the Park & City's Recovery

During the brief time that the wheel was open, it attracted new visitors and increased visits to:

- Museums and Gardens
- Local Merchants in Inner Sunset
- Nearby Commercial Corridors

Funds from the wheel will be used to support free public concerts and shows in the Music Concourse as well as Jerry Garcia Ampitheater in the south part of the city helping our entertainment industry to recover

• Helps to fulfill the original purpose of the Music Concourse

By attracting visitors, the Wheel can support essential economic recovery for Golden Gate Park, the Park's cultural institutions, the neighborhood and the City itself as it seeks to draw tourists back to San Francisco when health officials deem it safe.


