

Extension Request for Temporary Installation

Given the negative COVID-19 impact, SFRPD is proposing to extend the Permit for 4 years:

Fulfill Original Expectations of Operations – Only Open 39 Days

With the future availability of operational days for the wheel and future capacity limits unknown, this permit modification will both:

- Accommodate the anticipated riders from the original permit
- Provide for an increase in ridership to help offset the financial hardship suffered by the Operator.

Support the Park & City's Recovery

During the brief time that the wheel was open, it attracted new visitors and increased visits to Museums and Gardens, Local Merchants in Inner Sunset & Nearby Commercial Corridors

By attracting visitors, the Wheel can support essential economic recovery for Golden Gate Park, the Park's cultural institutions, the neighborhood and the City itself as it seeks to draw tourists back to San Francisco when health officials deem it safe.







Responding to HPC Concerns - Lighting

In response to HPC Conditions of Approval, RPD gathered additional feedback and implemented the following changes:

- Lights turned on after 10 pm and only minimal safety lighting is turned
- The light show no longer has white lights in the last hour of programming.
- To date no impact found





Reducing Noise

Step 1: Generator is No Longer Running At Night

Step 2: Alternative Generator Identified

- Considerably quieter
- Existing generator is approximately 4 times louder than the proposed new one

Step 3: We are exploring sound attenuation solutions. The following slides show one example, using Echo Barriers.



City Economists' Conclusion

- San Francisco's economy has performed much worse than other large U.S. cities, over the past year.
- This can be attributed to three major factors:
 - Safety-conscious behavior and regulation, which has also contributed to the city's very low COVID-19 death rate.
 - An absence of tourists and in-commuters.
 - Out-migration at a greater level than other cities.
- Like in other cities, low-wage service workers have borne the brunt of unemployment in San Francisco. Hiring in high-wage office industries is back to pre-COVID levels, though the work occurring remotely.
- Until office workers and hotel guests return, the unemployment rate is likely to remain elevated.
- Decisions that office workers and their employers make, about the prevalence of remote work after the pandemic, will likely drive the office and housing markets in the near-to-medium term.
- Quality of life improvements including re-opening of entertainment businesses – will tip the balance


