# MAYOR LEE ANNOUNCES EXPANSION OF QUALITY CHILD CARE SERVICES FOR HOMELESS FAMILIES IN SAN FRANCISCO

Mayor will commit \$2.1 million to provide child care services for 140 children under the age of five

**San Francisco, CA**—Mayor Edwin M. Lee today announced a \$2.1 million investment to provide child care services for 140 families experiencing homelessness currently waitlisted for child support programs.

This investment will expand the Accessible Child Care Expedited for the Shelter System (ACCESS) initiative, which provides child care services for families dealing with homelessness. With this expansion, the city will serve all eligible children under the age of the five on the ACCESS waitlist. As a result, these children and families will receive continuity of quality care until kindergarten. This is the Mayor's latest investment to eliminate homelessness in San Francisco families.

"Families dealing with the stress of homelessness should not have to worry about the additional complications of child care," said Mayor Lee. "We need to support families in

every way possible to move them into a stable living situation, and childcare services are a part of that effort."

The ACCESS homeless child care program was created in 2005 to provide homeless families with young children access to high quality child care. The ACCESS program currently serves an average of 150 children per year.

The program has been limited to serving children under the age of three, and a waitlist of more than 140 homeless children under the age of five exists today. Mayor Lee will expand funding for ACCESS by \$2.1 million as a component of his budget proposal announcement later this month.

"Having childcare means I am able to work," said Jackie Evans, who is enrolled in the ACCESS program. "After I had my baby, I didn't think I would be able to go back to my job. Then I found out about the program. Finding a childcare provider was taxing, but once I found one, it worked out perfectly."

The families currently on the waiting list include those who are unsheltered, in shelter, residing in overcrowded households, or living in SROs. Remaining in a nurturing quality child care setting can be a powerfully stabilizing influence for children and families experiencing homelessness of all kinds, and a key driver in breaking the cycle of intergenerational poverty.

"Homeless and foster youth are the most vulnerable San Francisco residents and it is unconscionable that even one homeless child is on a waitlist for early childcare services," said Supervisor Ahsha Safaí. "During the years when my children were in preschool, paying monthly tuition was equivalent to paying an additional second rent or a mortgage. I applaud Mayor Lee for taking swift action to fund early child care for all homeless children."

"As a parent of a young daughter, I know how challenging it can be to find affordable and quality childcare in San Francisco," said Supervisor Jeff Sheehy. "Expanding childcare services to additional 140 homeless children will provide them and their families critical support for a better future."

"This funding will make a significant impact to close the funding gap for children 0-5 in need of continuity of care," said Supervisor Norman Yee, who previously passed legislation to create the Infant and Toddler Early Learning Scholarship Fund. "The focus of this funding will be on infants and toddlers which are the least supported age group in San Francisco and this investment will help the most vulnerable homeless families gain access to quality care, which is a fundamental building block for children's educational and emotional development.

"Every child should have a safe, enriching place to learn, grow and play," said September Jarrett, Director of the Office of Early Care and Education. "Quality child care helps these children develop to their full potential and provides much-needed stability in their lives."

"Quality child care and family support services are vital to break the cycle of homelessness and poverty," said Martha Ryan, Executive Director, of Homeless Prenatal Program, which supports the expansion of the ACCESS program. "Child care is absolutely essential to give hope and opportunities to families. Without child care, how can you find housing, or get a job and earn a living to exit poverty."

Mayor Lee has overseen efforts to address family homelessness by working with Hamilton Families and philanthropic groups on the Heading Home Campaign. This initiative, which includes \$30 million in private funds, aims to end chronic family homelessness in San Francisco and has found housing for more than 140 families to date. The City has contributed \$4.5 million to the program, which is in addition to the \$40 million it spends annually on family homelessness.

**About the Office of Early Care and Education:** The San Francisco Office of Early Care and Education (OECE) was created by Mayor Edwin Lee in 2012. # MAYOR LEE ANNOUNCES TWO-YEAR INVESTMENT PLAN FOR STREET REPAVING PROJECTS

Proposal will provide nearly \$90 million for street improvement measures

**San Francisco, CA**— Mayor Edwin M. Lee today announced his two-year investment for street resurfacing projects in San Francisco, pledging to commit nearly \$90 million to pay for pothole repair, repaying, striping and other safety measures to improve the City's roads.

"San Franciscans deserve streets that are smooth and easy to travel on, and won't result in wear-and-tear on their vehicles or create hazards for cyclists and pedestrians," said Mayor Lee. "Our capital budget will improve these daily quality-of-life issues, while also making critical investments that will have lasting impact for generations to come."

Mayor Lee made the investment announcement at a street resurfacing project on 29th Avenue between Cabrillo and Fulton streets. Street resurfacing will be funded at \$89.5 million over two years, continuing the City's progress towards improving the City's Pavement Condition Index (PCI) score to 70 by 2025. A higher PCI score means fewer potholes, less wear and tear on vehicles, smoother rides for all road users, and reduced long-term maintenance costs.

During the past five years, nearly 3,900 blocks have been resurfaced in San Francisco—a strategic investment that has led to safer and smoother roads. The City's regionally tracked roadway conditions have shown a steady improvement since San Francisco voters approved the \$248 million Road Repaving and Street Safety Bond in 2011, with additional funding support from Mayor Lee to advance the progress in subsequent years. The bolstered capital investment has allowed San Francisco to resurface more than 700 blocks a year, far exceeding the 400 or so blocks that had been paved annually prior to the bond approval.

"Mayor Lee has made it a mission of his to improve the condition of the streets of San Francisco and one that he has delivered on with sustained investment in roadway improvements," said San Francisco Public Works Director Mohammed Nuru. "Taking care of our roads is a priority and one that benefits everyone, whether you drive, bike, walk or ride a bus."

The street resurfacing investment is part of Mayor Lee's \$530.3 million proposed two-year capital budget to invest in San Francisco's future. The proposed capital budget is nearly seven times larger than the one in 2011, when Mayor Lee took office.

Mayor Lee's Fiscal Year FY 2017-18 and FY 2018-19 proposed capital budget follows the adopted Ten-Year Capital Plan by fully funding the General Fund pay-as-you-go capital program over both years, demonstrating the City's commitment to continuous improvement with a record investment of \$137.8 million in the first year and \$147.3 million in the second year.

"Investments in our infrastructure over the next two years will create a more resilient and safer city." said City Administrator Naomi M. Kelly and Chair of the Capital Planning Committee. "In the Capital Plan we emphasize investments we can make now to create a stronger city today and for the future."

These funds will make critical seismic repairs, transportation system improvements, and create safer streets for pedestrians, bicyclists, and drivers. Some of the highlights include the following:

- Largest General Fund Capital Budget Ever: \$137.8 million and 147.3 million are the two largest single-year allocations of General Fund capital in San Francisco's history. In addition, this is the fourth consecutive year that Mayor Lee has funded the first budget year at the Capital Plan-recommended level and the first time ever that the second year is also funded at the Plan-recommended level.
- **Better Streets**: Street resurfacing, the largest single expenditure in the capital budget, is funded at \$89.5 million over two years, on pace to achieve a Pavement Condition Index (PCI) score of 70 by the City's target date of 2025. A higher PCI score means fewer potholes, less wear and tear on vehicles, smoother rides for all road users, and reduced long-term maintenance costs.
- **Resiliency**: \$3 million to continue plans to fortify and upgrade the Seawall, which serves as the foundation for the waterfront from Fisherman's Wharf to Mission Creek just south of AT&T Park, and \$300,000 to support the Mayor's Sea Level Rise Action Plan
- Safer Streets: \$1.25 million to supported coordinated bicycle and pedestrian safety improvements as part of the City's Vision Zero initiative. These improvements will be coordinated with planned construction projects in the right-of-way to minimize disturbances to neighborhoods. Planned projects will focus on the high-injury network and school-proximate projects. In addition to the commitment to repair tree-related sidewalk damage as part of the voter-approved Street Trees set-aside, \$2.9 million is proposed for sidewalk repair. The proposed budget also continues to fully fund the ADA Right-of-Way Curb Ramps program with \$11.8 million.
- Stronger Right-of-Ways: The proposed budget continues to fully fund the Street

Structure Repair program with nearly \$5 million for City-owned stairways, retaining walls, underpasses, and tunnels. For the first time, the proposed budget also funds all requested stair and wall replacement projects, which include the Funston Avenue retaining wall, Kearny Street stairs, Mullen Avenue stairs, and the 17<sup>th</sup> Avenue street stair and wall, as well as the 25<sup>th</sup> Street pedestrian bridge.

- •Restored Bridges: Building on past commitments, \$7.8 million in required local match will be used to leverage \$55 million in federal funds to repair structural steel elements at the 3<sup>rd</sup> Street Bridge and rehabilitate the Islais Creek Bridge with equipment and system upgrades, bridge deck and fender system replacement, painting, and corrosion
- **Creating Jobs**: The \$530.3 million to be invested through the capital budget will support more than 4,400 jobs over the life of the projects that are funded.

# •Neighborhood and Livability Improvements:

- o o Developer-paid impact fees will fund \$92.2 million in streetscape and open space improvements in rapidly growing areas such as South of Market, Market Octavia, Eastern Neighborhoods, Rincon Hill, and Transit Center.

  \$2 million in funding for Dig Once, which takes advantage of existing planned street construction to add high-speed internet fiber conduit, reducing the
- number of times streets must be torn up.

"In real dollars, Mayor Lee has done more to improve infrastructure than any other Mayor over the past 50 years," said Brian Strong, Chief Resilience Officer and Director of the Office of Resilience and Capital Planning for the City.

The City and County of San Francisco's Capital Planning Committee makes recommendations to the Mayor and Board of Supervisors on infrastructure needs and spending. It is Chaired by the City Administrator and includes the President of the Board of Supervisors, Controller, Budget Director, Planning Director, Public Works Director, Port Director, Municipal Transportation Agency Director, Airport Director, Public Utilities Commission General Manager, and Parks and Recreation General Manager.

The Capital Planning Committee's recommendations are guided by the adopted FY 2017-18 through 2026-27 Ten-Year Capital Plan. For more information, go to: onesanfrancisco.org.

**San Francisco, CA**— Mayor Edwin M. Lee and the Recreation and Park Department announced today that San Francisco is the first and only city in the United States where all residents have access to a park within a 10-minute walk. The findings were part of the Trust for Public Land's (TPL) Park Score, an assessment of the nation's 100 largest cities.

During Mayor Lee's tenure, San Francisco has invested \$355 million in parks and open space projects. For his upcoming two-year budget, Mayor Lee will include \$84.4 million in capital projects for the Recreation and Park Department, maintaining record levels of investment in the city's parks and open spaces. The \$84 million investment in capital projects represents an 81 percent increase from 2015 levels.

"In San Francisco, we want everyone to enjoy the prosperity of this city, which is why it is particularly meaningful that we have a parks system that is accessible and enjoyable for all of our residents," said Mayor Lee. "We are proud to be the first city in the nation to have a least one open space within a 10 minute walk of every resident. We are maintaining our record

investment into our local parks so that all San Franciscans can continue to enjoy our wonderful natural environment."

The announcement took place at the newly renovated Hilltop Park, a recreational facility with a state-of-the-art skate park and playground. To get to the park, Mayor Lee, Recreation and Park General Manager Phil Ginsburg, and TPL's Urban Parks Director Adrian Benepe took a 10-minute walk with children from the Family & Children Empowerment Services child care center located at 100 Whitney Young Circle.

According to TPL, a 10-minute walk, or a distance of one-half mile, is the standard for urban park systems. Though walking speeds vary, the U.S. Department of Transportation agrees that most people can walk a half-mile in about 10 minutes. TPL and park planners across the country rely on sophisticated technology and data to measure the 10-minute walk and have concluded that everyone should be able to reach a park in that amount of time, no matter what kind of neighborhood they live in.

"Most city residents won't walk more than 10 minutes to get to shopping, transit, or parks, so close-to-home access to parks is vital for public health, clean environments, and thriving, equitable communities," said Adrian Benepe, The Trust for Public Land's SVP & Urban Parks Director. "This is an enormous achievement, based on years of dedicated and thoughtful work and planning, and San Francisco should be very proud."

To achieve the distinction as the nation's first city with every resident living within a 10-minute walk of a park or open space, the Recreation and Park Department has been actively maximizing the recreational use of park land citywide as well as acquiring new land to develop into public parks.

In recent years, San Francisco has added the Golden Gate Park CommUNITY Garden, Interior Greenbelt, Geneva Community Garden, Noe Valley Town Square, 17th and Folsom Streets Park, Francisco Reservoir, and 900 Innes Ave, also known as Indian Basin, to the City's list of new parks.

"Our goal is to have clean, safe parks accessible to all San Franciscans," said Phil Ginsburg, SF Rec and Park General Manager. "We are thrilled to see our efforts recognized and grateful to Mayor Lee for his unwavering support and firm belief in the importance of open space."

In addition to planning, developing, and maintaining lands under its jurisdiction, the Recreation and Park Department continues to work with other city agencies to address open space needs around the City. The Recreation and Park Department brings park expertise and perspective to emerging open space projects, working closely to advise on open space needs. As a result, parks such as the SOMA West Skate and Dog Park, Tunnel Top Park, Progress Park, Playland at 43<sup>rd</sup> Ave, and others have become neighborhood parks that serve San Francisco residents.
